# Notice of Race (NoR)

Amendment#1 – 2024-07-22

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

- 1 **RULES**
- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 [DP] RRS 40.1 applies and is amended so that it applies at all times while afloat.
- 1.3 RRS Appendix T "Arbitration" will apply.
- A boat shall sail with the sail number with which she was registered. The race committee may permit a 1.4 change upon request. Failure to sail with the registered or approved number will result in a 10% scoring penalty added to her race score sailed nearest in time to that of the incident. This penalty will be imposed without a hearing and will conform to RRS 44.3(c). This changes RRS 63.1 and RRS A5.
- 1.5 The CORK / Sail Kingston Code of Conduct and Safe Sport Policy Package applies and can be found at: CORK Code of Conduct and CORK Safe Sport Package.
- 2 SAILING INSTRUCTIONS
- 2.1 The sailing instructions will be posted on the online official notice board.
- COMMUNICATION 3
- 3.1 The online official notice board is located at: Official Notice Board
- 3.2 [DP] While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.
- **ELIGIBILITY AND ENTRY** 4
- 4.1 The regatta is open to boats of the Club 420, ILCA 7, ILCA 6, ILCA 4 and 29er classes.
- 4.2 For boats to be accepted for this event, the online application must be completed at event registration and all fees must be received by 1800 August 5, 2024. No entries will be accepted after this time. Any registration changes must be made using the online official notice board with the equipment change feature.





- 4.3 As part of the online registration process participants (or parent/guardian if under 18) will be required to electronically sign the CORK/Sail Kingston waiver, copy of the waiver can be found here: <a href="CORK">CORK</a>
  <a href="Waiver">Waiver</a>, and all Sail Canada event athletes and support persons are required to electronically sign the Sail Canada consent which can be found here: Sail Canada Consent.</a>
- 4.4 To finish the entry process, participants must complete the onsite check-in process at the CORK registration desk which includes the safety and other requirements checklist signoff as described in Addendum 1.

### 5 **FEES AND REFUNDS**

- 5.1 The entry fee covers racing, \$25 per person Sail Canada Regatta fee and a regatta souvenir.
- 5.2 In the case of event cancellation or postponement by CORK, all fees except for bank charges will be refunded.
- 5.3 All fees except for bank charges will be refunded to boats that cancel on or before **July 23, 2024**.
- 6 **IDPI ADVERTISING**
- 6.1 Boats may be required to display advertising chosen and supplied by the organizing authority.
- 7 QUALIFYING SERIES AND FINAL SERIES
- 7.1 The regatta may consist of a qualifying series and a final series. The decision will be made at the end of registration.
- 7.2 [DP] Boats sailing in a qualifying series and final series will be required to display fleet identification colours. It is the competitor's responsibility to bring their own flight/fleet reusable identification sleeves (Yellow, Blue, Red, Green) to the event. The size of the flight/fleet identification sleeves/sheets shall be at least 11" and shall cover all around the bottom mast section between the boom and the boom vang fitting. No single use identification colour sheets, elastics or tape may be used. Sleeves will be available for purchase from the CORK office and website.

- 8.1 One extra race per day may be sailed, provided that the event is no more than one race ahead of schedule.
- 9 **VENUE**
- 9.1 Sailing will be in Lake Ontario South of Portsmouth Olympic Harbour.
- 10 **COURSES**
- 10.1 The courses to be sailed will be either windward/leeward or ILCA class trapezoid.
- 11 PENALTY SYSTEM
- 11.1 RRS Appendix P, Special Procedures for RRS 42 will apply. Appendix P2.3 is deleted, and P2.2 is changed to: "When a boat is penalized a second and subsequent times during the regatta, she shall promptly retire. If she fails to do so she shall be disqualified without a hearing and her score shall not be excluded."
- 11.2 For the 29er class, RRS 44.1 and RRS P2.1 are changed so that the Two-Turns penalty is replaced by the One-Turn penalty.
- 12 **SCORING**
- 12.1 One race is required to constitute a series.
- 12.2 When fewer than five races have been completed, a boat's series score will be the total of her race scores.
- 12.3 When from five to nine races have been completed, a boat's series score will be her total of her race scores excluding her worst score.
- 12.4 When ten or more races have been completed, a boat's score will be the total of her race scores excluding her two worst scores.
- 12.5 Eleven races are scheduled for Club 420, ILCA7, ILCA 6, ILCA 4 and fifteen races are scheduled for 29ers.
- 13 **IDPI INPI SUPPORT PERSONNEL AND VESSELS**
- 13.1 There is a \$80 fee (+ HST); support persons shall register online at: **event registration**.
- 14 **[DP]** BERTHING
- 14.1 Boats shall be kept in their assigned places/area while they are in the boat park.

#### 15 **[DP] LAUNCHING**

- 15.1 Boats shall launch from and return to Portsmouth Olympic Harbour.
- 16 **PRIZES**
- 16.1 CORK will provide a variety of prizes depending on the number of competitors in the fleet. Some class associations may provide their own additional prizes.
- 16.2 Sail Canada Youth Championships and Sail Canada Senior Championships awards will be presented by Sail Canada.
- 16.3 Other awards may be given by Sail Canada and Helly Hansen.

#### 17 DISCLAIMER OF LIABILITY AND RISK STATEMENT

RRS 3 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone." Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- (a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event.
- (b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore.
- (c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omission.
- (d) Their boat is in good order, equipped to sail in the event and they are fit to participate.
- (e) The provision of a race management team, patrol boats and other officials and volunteers by the event organizers does not relieve them of their own responsibilities.
- (f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.

#### 18 **INSURANCE**

18.1 Each participating boat shall be insured with valid third-party liability insurance. The organizing authority does not accept any responsibility for verifying that a boat has valid third-party liability insurance.

### 19 [DP] CONCUSSION AWARENESS

## Addendum 1

## Competitors' safety and other requirements checklist

## • ILCA 7, 6, & 4

- I have ensured that my boat meets the class rules requirement for tie line or shock cord used to secure the centreboard to the boat.
- I have ensured that my boat meets class rules requirements for a retention line or shock cord installed to secure the mast in the event of a capsize.
- In the case of a qualifying/final series boats must, as per NoR 7.2, display reusable coloured flight/fleet identification sleeves.
- Each ILCA 6 and ILCA 7 sailor must be a member of the International Laser Class Association

### Club 420

- We have ensured that my boat meets the class rule requirement for a towing rope secured to the mast.
- A whistle shall be attached by a lanyard to the PFD.
- Each boat shall use a line attached from the rudder to the boat that will keep the rudder connected to the boat in the event of capsize or turtle.
- In the case of a qualifying/final series boats must, as per NoR 7.2, display reusable coloured flight/fleet identification sleeves.

## • 29er

- The boat shall be equipped with personal flotation devices (PFD) for each crew member to the minimum standard EN393 or ISO 12402-5 Level 50.
- Each competitor shall carry at all times a SOLAS approved whistle.
