Rock Ridge Country Club offers the following classes of Membership that include a variety of privileges from dining only to unrestricted access to golf, tennis, swimming and dining. Class restrictions by privilege, and age are as noted. Pricing is based on regular annual costs of membership including current applicable taxes; special assessments additional.

Joining members must pay a Dues Deposit of \$3,600. Dues Deposit to be credited back to the member at a rate of \$100/month. If the membership terminates prior to the full deposit being applied, any remaining balance is forfeited.
