Notice of Race – with Amendment 1

1 RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 RRS 40.1 applies.
- 1.3 RRS 44.1 is changed as follows: A boat may take a One-Turn Penalty as described in RRS 44.2 when she may have broken a rule of part 2 while racing
- 1.4 RRS 60.4(a)(2) is changed as follows: “(2) if it alleges a breach of a rule of Part 2 or rule 31 **and** is from a boat that was not involved in, and did not see, the incident, or ...”.
- 1.5 US Prescriptions to Part 5, Section B are deleted.
- 1.6 US Prescription to rule 63.1 is deleted.

2 ELIGIBILITY AND ENTRY

- 2.1 In accordance with RRS 75 boats must be entered by competitors who are members of appropriate sailing clubs. Those failing to comply are encouraged to apply for membership at the Tahoe Yacht Club. Another alternative would be to join the Scuttlebutt Sailing Club at no charge:

- 2.2 This event is open to class legal ILCA 4.7s, ILCA 6s, and ILCA 7s.
- 2.3 A minimum of four boats in a division are required in order to qualify for a start.
- 2.4 Eligible boats must enter online not later than 1200 hours, 9/12/26:

6 VENUE

The racing venue will be on the waters of Lake Tahoe near the Lake Forest launch ramp.

7 SCORING

7.1 Ten races are scheduled.

7.2 Three completed races constitutes a series.

7.3 For every five races completed, the worst score shall be discarded. If fewer than five races are completed, no scores will be discarded. This changes A2.1.

8 LAUNCHING

8.1 Launching will be available at the Tahoe City Public Utility District launch ramp adjacent to the US Coast Guard station in Lake Forest, near Tahoe City.

8.2 All boats will be required to obtain a TRPA boat Inspection seal before launching. This is free and mandatory. Boats must be clean, drained, and dry. Inspections can be completed at the Alpine Meadows Inspection Station located at 255 Alpine Meadows Rd. near Tahoe City.
