1. RULES

1.1. The regatta will be governed by the *World Sailing Racing Rules of Sailing 2021 – 2024* (referred to in this document as RRS), the Prescriptions of Sail Canada, and the rules of the *Cal 20 Class Association*.

2. SAILING INSTRUCTIONS

2.1. Sailing Instructions will be posted online on the KYC Website by 12:00 on April 3, and on the club notice board.

3. COMMUNICATION

3.1. The OFFICIAL NOTICE BOARD will be north of the main entrance just inside the KYC Clubhouse.

3.2. Boats may carry a VHF radio, however while racing, except in an emergency, a boat shall neither make radio transmissions nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

4. ELIGIBILITY AND ENTRY

4.1 The series is open to the Cal20 class.

4.2 A Cal 20 is eligible only if it is owned by a member of Cal 20 fleet 38 and the owner or one of his crew must be a member in good standing of the Cal 20 Association.

4.3 A Class Measurement Certificate is optional. However, to be eligible for a first, second or third place trophy, a Cal 20 must qualify for a valid Class Measurement Certificate upon that final day of racing if challenged. The cost to challenge and request

a measurement of any placing yacht shall be \$100.00 Cdn payable to the host Fleet and is refundable only upon the non-qualification of the boat being measured.

4.4 Total crew for each boat is limited to a maximum of four people and a minimum of two.

4.5 Entry is confirmed upon completion of registration and payment of fees. Registration will be available online at kitsyc.theclubspot.com/racing.

4.6 A minimum of four Cal 20 boats are required to be registered for each race day. If less than four boats have registered by 12:00 pm three days prior to the first race day of each series, the series will be cancelled.

5. FEES

5.1 There is a registration fee of \$100 for each series.

6. SCHEDULE

6.1. Boats are not required to check in prior to racing.

6.2. The 2022 Janet Stamper Spring Series shall take place on the following dates: Apr 10th, Apr 24th, May 15th, May 29th, Jun 12th

6.3 The 2022 Janet Stamper Fall Series shall take place on the following dates: Sep 4th, Sep 18th, Oct 2, Oct 16th, Oct 30th

6.4 The scheduled time of the first warning signal is 11:00.

6.5 No warning signal shall be made after 14:30.

7. RACE FORMAT

7.1. There is no maximum number of races.

7.2. Subsequent races after the first race of the day will be started as soon as practicable after the conclusion of the preceding race.

8. VENUE

8.1. The venue for this event will be Kitsilano Yacht Club.

8.2. Racing will take place on English Bay in the vicinity of Kitsilano Yacht Club.

9. THE COURSES

9.1. Courses will be described in the Sailing Instructions.

10. SCORING

10.1 One race will constitute a series.

10.2 The Janet Stamper Series will be scored according to *RRS Appendix A (Scoring)* using the *Low Point Scoring System*, with the following provisions for discarding worst scores:

Completed Races	Discards
1-3	0
4-6	1
7-10	2
11-15	3
16 or more	4

10.3 Scoring Abbreviations, as listed in *RRS Appendix A(Scoring)*, and Points Given for each listed below:

Scoring Abbreviation	Points Given
DNC, DSQ, UFD, BFD, DNE	Registrants + 1
DNS, OCS	Starters + 1
DNF, RET	Finishers + 1

11. PRIZES

11.1 Prizes will be awarded for First, Second, and Third place overall. To calculate this, a boat's Janet Stamper Spring series score shall be added to her Janet Stamper Fall series score.
