

NOTICE OF RACE



Rocky Mountain Snipe Championship

Aug. 31 – Sept. 1, 2024

ORGANIZING AUTHORITY:

Snipe Fleet #210 and Union Sailing Club in co-operation with SCIRA USA

1. RULES

The regatta will be governed by:

- 1.1 The rules as defined in the Racing Rules of Sailing (RRS).
- 1.2 The SCIRA Rules of Conduct for Conducting National and Local Regattas (RoC) available at: https://www.snipe.org/images/2017/2018/SCIRA-2018-roc nochampionship-final.pdf as modified in the Sailing Instructions.
- 1.3 National prescriptions of US Sailing will apply.
- 1.4 RRS Appendix T will apply.

2. SAILING INSTRUCTIONS

The Sailing Instructions will be made available on the regatta website https://snipeusa.com/regatta/MagypADICs before the event and at the Competitor's meeting.

3. COMMUNICATION

From the first warning until the end of the last race of the day, except in an emergency or when using equipment provided by the race committee, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communications that is not available to all boats.

4. ENTRY AND ELIGIBILITY

- 4.1 Boats shall enter the Regatta by completing the on-line registration and paying the entry fee on the event website: https://snipeusa.com/regatta/MagypADICs
- 4.2 Full payment must be received for registration to be complete.

5. FEES

\$100.00 if received by 18:00 on August 24, 2024, \$125.00 if received thereafter. Entry fee includes dinner for skipper and crew. Additional dinner tickets can be purchased online for \$25.00.

All entries must be completed online.

6. ADVERTISING

- 6.1 Advertising is permitted in accordance with WS Regulation 20.
- 6.2 Boats may be requested to display advertising chosen and supplied by the organizing authority.

7. RACING SCHEDULE

No more than seven (7) races are scheduled with one discard upon completion of six (6) races.

Saturday, August 31 10:00 am – Competitor's Meeting

11:00 am - Four (4) or more races back-to-back

<u>Sunday, September 1</u> 10:00 am – Three (3) or more races back-to-back

8. VENUE

- 8.1 Union Sailing Club, County Road 26, Longmont, Colorado 80504.
- 8.2 Trailer launching is available at the public launch ramp at the Union Reservoir Park site. Union Sailing Club's launch ramp is dolly-launch only.
- 8.3 Day Park Pass is REQUIRED \$15/day for vehicle and \$15/day for trailered boat. Passes can be purchased at the club.
- 8.4 Any boats being brought onsite must be inspected for Aquatic Nuisance Species (ANS) by the Park staff prior to launching. USC is working on arranging boat inspections at the club Saturday morning prior to launching.
- 8.5 All PDFs are required to have whistle.
- 8.6 Due to the Labor Day holiday weekend, traffic on the city side of the lake tends to back up and create delays. There is a back entrance to USC that bypasses the city entrance by taking County Road 3 1/2 off Ken Pratt Road. A map will be sent to registered boats prior to the event.

9. COURSES

The courses to be sailed as per the Sailing Instructions.

10. PENALTY SYSTEM

The Scoring Penalty, RRS 44.3 applies. The penalty is 2 (two) places.

11. SCORING

If six (6) or more races are scored, each boat's series score shall be the total of her race scores excluding her worst score.

12. RISK STATEMENT

RRS 3 states: "The responsibility for a boat's decision to participate in a race or to continue to race is hers alone." By Participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.

13. PRIZES

Skipper and crew for first through fifth places if registration. The top junior team will also be awarded a prize.

14. RIGHTS TO USE NAME AND LIKENESS

By participating in this event, competitors automatically grant to SCIRA, the organizing authority and the event sponsors the right, in perpetuity, to make, use, and show, at their discretion, any photography, audio and video recording, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.
