ACTIVE MEMBERS

An Active Member is any single adult or couple who has satisfactorily completed the admission requirements of Marathon Yacht Club, and subsequently been approved by the Membership Committee and the Board of Governors. A couple is deemed to be two adults residing at the same address, and both parties are deemed to be Members with all rights of Membership including the right to vote (one vote per couple), to hold office, to serve on committees, and to use the Club and all of its facilities, as well as full reciprocity with the Florida Council of Yacht Clubs. The Member's minor children residing with the Member also have the right to use the Club and its facilities.

Both parties of a couple cannot simultaneously serve on the Board of Governors or the Finance or Nominating Committees. A couple has one Membership number and all charges accrue to that single number. Both parties of a couple are jointly and severally responsible for all fees and charges.

Active Member applicants shall pay the applicable MYC Initiation Fee, Annual Dues, a Monthly Maintenance Fee of \$10, and be responsible for annual Club usage minimums of \$1200 per couple, or \$600 if single. Active Member applicants shall pay an Application Fee of \$50.00. All fees quoted herein shall be subject to applicable sales tax.

JUNIOR MEMBERS

Any person under the age of 50 or couple with one party under the age of 50 may apply for Junior Membership. The Junior Members shall pay a portion of the Annual Dues in accordance with the following percentages:

- A) between the age of 35-49 on or before December 31st of the calendar year turning 49, 70%;
- B) between the age of 21 and 34 on or before December 31st of the calendar year turning 34, 50%.

Junior Membership shall be limited to full time residents of the Florida Keys. Existing Junior Members who are not Keys residents shall be exempt from this requirement. When no longer qualifying by age for a Junior Membership category, the Member shall automatically convert to, as applicable, Junior "A" or the Active Member category of membership.

The Junior Members shall be subject to the regular Admission process and once accepted into membership shall have all the privileges and responsibilities of an Active Member and shall be effective upon BOG approval.

Junior Member applicants shall pay the applicable MYC Initiation Fee, Annual Dues, a Monthly Maintenance Fee of \$10, and be responsible for annual Club usage minimums of \$1200 per couple, or \$600 if single. Junior Member applicants shall pay an Application Fee of \$50.00. All fees quoted herein shall be subject to applicable sales tax.

Any Marathon Yacht Club Member utilizing Florida Council of Yacht Club (FCYC) privileges shall meet one of the following two requirement based upon their residency.

- 1) Resident of the Florida Keys The Member must use Marathon Yacht Club as their primary club and meet the required MYC minimum annual spending.
- 2) Not a resident of the Florida Keys –The Member must use the Marathon Yacht Club as their primary club and meet the required MYC minimum annual spending in person at Marathon Yacht Club.

Information for Applicants to the Marathon Yacht Club

The Application must be completed in full, including:

- 1. Two (2) members as sponsors, with detailed information and/or letters of recommendation. Make sure the sponsors sign the application as well as completing the sponsorship portion.
- 2. Short biography of member or member/spouse (i.e., Bob enjoyed a long career in financial management, franchising and business ownership. Kathy spent 20 years in sales management for a major electronics firm. They purchased a home on Grassy Key last year and spend at least the four cold winter months here in the Keys. Their interests include gardening, enjoying time with friends and look forward to new friends at MYC).
- 3. Supply a photo of you and your spouse or significant other. This will be used to introduce you to the membership on our video display and in our monthly newsletter.
- 4. Complete the data sheet on name tags and membership cards.
- 5. Enclose your check for \$53.75 (\$50 plus sales tax), which is a non-refundable Application Fee.
- 6. Please note, your application will be posted for members to view. (process lasts 10 days).

Membership in Marathon Yacht Club does not include a guarantee of dockage. Dockage is subject to availability and the size requirement for the vessel(s) in question.

Marathon Yacht Club is a proud member of the Florida Council of Yacht Clubs (FCYC) and is also listed in the Register of American Yacht Clubs. As a member, you will be entitled to a copy of the MYC Membership Log and provided a copy of the FCYC Register at time of membership. You will have reciprocity with other FCYC Clubs throughout the State of Florida and other Yacht Clubs in the Registry.

Membership Eligibility

- Adults that are twenty-one (21) years of age or older.
- Two (2) active or Junior members in good standing as sponsors.
- Must provide proof of Monroe County residency to qualify for Junior Membership.
