## DATE, VENUE, ORGANIZING AUTHORITY, and O'PEN SKIFF ATTITUDE

The 2021 O'pen Skiff Midwinters will be held in Charleston, South Carolina hosted by the Carolina Yacht Club. The Organizing Authority for this regatta is the Carolina Yacht Club in association with the North American O'pen Skiff Class. The regatta will be governed by *the Racing Rules of Sailing (RRS)*.

**Important Event Introduction:** The purpose of this event is to run a fun event for youth sailors in a more loosely competitive style in dynamic junior boats. Results are not nearly as important as everyone having a good time sailing. Our goal is to improve the sailors' skills, make new friends, and have a ton of fun. This event will be a combination of "conventional" style race formats with unorthodox "Un-Regatta" style courses and events. Don't expect conventional round-the-buoys racing or upwind starts for all races. Capsizes, freestyle, speed and fun will be required. If you are a hard-core racer with rule book in hand, this event may not be for you. If you want to have fun, challenge your limits, and pioneer a new chapter in Youth Sailing, we invite you to come join the fun.

## ELEGIBILITY

The fleet is comprised of two Divisions. This modifies Class Rule C.2.3

- U13 Division: Competitors born after Dec 31st, 2008
- Open Division (all ages welcome)

**A minimum of 15 sailors must be registered by November 1<sup>st</sup>, 2021.**

The number of races each day will be determined by the Race Committee. Any changes to the start time will be posted on the Online Notice Board by 7:00 pm of the preceding day.

### **RULES**

The regatta rules will be outlined in the Sailing Instructions which may modify standard World Sailing rules, and the OSCA's Class Rules where applicable. Boats may be required to display advertising chosen and supplied by the Organizing Authority.

### **HELMETS**

Protective helmets are recommended.

### **ENTRY**

### **ENTRY FEES**

The entry fee is \$75 per sailor, and includes breakfasts & lunches. Entry Fee will increase to \$100 on November 5<sup>th</sup>, 2021. Limited 2021 charter boats are available for \$150.

### **MEASUREMENTS AND CHECKS**

Boats and sails must be in conformity with the O'pen Skiff Class Rules. The Race Committee may check boats and crews before, during and after the races. Both Racing Sails and Dacron Sails will be accepted.

### **SAILING INSTRUCTIONS**

The Sailing Instructions will be available prior to the event on the event's website and will be given to each participant at check-in.

### **RACING FORMAT**

The number of races for all the Divisions will be at the discretion of the Race Committee. Three valid races are required to constitute the championship. There will be separate rankings for each age group division. At the discretion of the Race Committee, age groups may or may not be raced together as one fleet.

### **SCORING SYSTEM**

The Low Point scoring system of RRS Appendix A will apply. There will be a discard race for every 5 races completed, i.e. one discard for 5 races, two discards for 10, three discards for 15, etc.

### **JURY**

On the water umpires may be appointed by the regatta organizers. Their decisions will be final.

### **ADVERTISING**

Advertising is permitted as per O'pen Skiff Class Rules.

### **PRIZES**

Prizes will be awarded to the first three boats per division, and the top female in U13 & Open divisions.

### **LIABILITIES**

It is the competitor's decision to enter the regatta or to start and continue in any race. Competitors shall

accept that their participation in the regatta is at their exclusive risk in every respect. World Sailing RRS Rule 4, Decision to Race, will apply. The Organizing Authority, the respective Host Sailing Club, their officers, members, servants and agents, Skiff Sport and the Race Management team accept no responsibility with respect to loss of life, personal injury or loss or damage to property which may be sustained by reason of their participation or intended participation in the regatta or arising in connection with the regatta.
