

# Warwick Yacht and Country Club, Inc. Membership Application: June 2023 Revision

Dear Prospective Member,

Thank you for your interest in Warwick Yacht and Country Club, Inc. We hope you sail through the application process and find yourself enjoying the camaraderie of membership. As you fill out the Membership Application, some questions may arise. We hope this will help clarify matters for you.

Initiation Fee: \$1,000.00

Stock: \$100 per share

**Re-instatement Fee: \$500.** Fee for those that own stock in Warwick Yacht & Country Club and have been a prior Class Member and resigned or inactive for at least one full year (12 months).

**Processing Fee: \$25** 

### Classes of membership are as follows:

**Full Resident Member**, <u>Class A</u>. Such member shall consist of a person who is duly elected to membership by the Board of Directors in accordance with the procedures herein established and who owns stock. One share if single and two shares if membership is for a couple, both of which must be approved by the board and living at the same address. Dependents of the stock members will have privileges of membership (except voting) if listed on the membership application, under 26 years of age and living at the same address. Dependents not listed on the membership application may be added with approval of the board.

#### Monthly Dues and Maintenance Fee: \$215; Monthly Food & Beverage Minimum \$40

**Military Member**, <u>Class F</u>. Such member shall consist of a person who is duly elected to membership by the Board of Directors in accordance with the club bylaws established and who is a member of the Armed Forces and on active duty in Virginia. Such person shall not be required to own stock.

#### Monthly Dues: \$215; Monthly Food & Beverage Minimum \$40

We have asked for some information about you.

**Full Name**, **Employer** and **Social Security Number** information is needed for the person(s) in whose name the membership will be held. We would like you to know that every attempt is made to keep your personal information private. Before your application is submitted to the Membership Committee your social security number is removed. WYCC will obtain a credit report and background check as part of your application.

**Stock Fees: \$100 per share.** Single Memberships (with or without minor dependents) require the purchase of <a href="mailto:one-share">one-share</a> of stock. Married/Couple Memberships (with or without dependents) require the purchase of <a href="mailto:two">two</a> shares of stock.

**Member Sponsors**: Two members in good standing. If you are new to the area, please contact the Manager.

Personal Reference/Emergency Contact: Who to contact in case of emergency.

**Area(s) of Interest:** Finally, you will get to the fun part: WYCC has a small staff for administrative needs, dining amenities and seasonal recreational activities. Traditionally, all other aspects of the Club are supported by member volunteers. We encourage and expect our members to get involved.

Upon approval of your application, you will receive a "Welcome Kit" from the club.

We hope the application process goes smoothly for you and we look forward to meeting you and processing your application. We wish you fair winds and following seas!

Dear Membership Applicant,

Your desire to submit an application for membership to Warwick Yacht & Country Club is appreciated. The procedures to process your application are as follows:

First, the completed application, along with a \$25 nonrefundable processing fee, stock cost, initiation fee/reinstatement fee/summer membership fee, and signatures from two member sponsors must be presented to the Club office for processing. Incomplete applications will not be processed.

Per Club Bylaws your completed application will be forwarded to the Secretary and your names will be posted on the Club Bulletin Board for a minimum of (7) days. A credit and background check will be obtained by the Membership Committee designee and your application will be presented to the Board of Directors for approval. You will be informed of the results.

You will be able to use the Club facilities as a member as soon as the above approvals have been met. During the application process you may only use the Club facilities as a guest of a member. WYCC has a goal to process and finalize the approvals within 2 to 3 weeks.
