# Marathon Yacht Club Membership Types

## **ACTIVE MEMBERS**

An Active Member is any single adult or couple who has satisfactorily completed the admission requirements of Marathon Yacht Club, and subsequently been approved by the Membership Committee and the Board of Governors. A couple is deemed to be two adults residing at the same address, and both parties are deemed to be Members with all rights of Membership including the right to vote (one vote per couple), to hold office, to serve on committees, and to use the Club and all of its facilities, as well as full reciprocity with the Florida Council of Yacht Clubs. The Member's minor children residing with the Member also have the right to use the Club and its facilities.

Both parties of a couple cannot simultaneously serve on the Board of Governors or the Finance or Nominating Committees. A couple has one Membership number and all charges accrue to that single number. Both parties of a couple are jointly and severally responsible for all fees and charges.

Active Member applicants shall pay the applicable MYC Initiation Fee, Annual Dues, a Monthly Maintenance Fee of \$10, and be responsible for annual Club usage minimums of \$600 per couple, or \$450 if single. Active Member applicants shall pay an Application Fee of \$50.00. All fees quoted herein shall be subject to applicable sales tax.

## **LOCAL AREA MEMBERSHIP PROGRAM, "LAMP"**

A Florida Keys resident living in the area for 12 months per year and not previously a Member of MYC is eligible for a LAMP Membership. Applicants must satisfactorily complete the same admission requirements of the Marathon Yacht Club as Active Members. LAMP Members shall have full Club privileges in the Pool, Bar, Dining Room, Ship's Store and Docks. LAMP Members shall have no voting privileges, hold office, or be accorded FCYC reciprocity. LAMP Members may serve on committees, with the exception of the Finance and Nominating Committees. At the end of three (3) years, LAMP Members must convert to full Active Membership or resign from the Club.

LAMP Members shall pay 50% of the MYC Initiation Fee, 50% of MYC Annual Dues, be responsible for a Monthly Maintenance Fee of \$10, and annual Club usage minimums of \$600 per couple, or \$450 if single. Annual Dues must be paid in full each year. LAMP Member applicants shall pay an Application Fee of \$50.00. All fees quoted herein shall be subject to applicable sales tax.

## **JUNIOR MEMBERS**

Any person under the age of 50 or couple with one party under the age of 50 may apply for Junior Membership. The Junior Members shall pay a portion of the Annual Dues in accordance with the following percentages:

**JUNIOR A (35-49)** Between the age of 35-49 on or before December 31st, 70%

**JUNIOR B (21-34)** Between the age of 21 and 34 on or before December 31st, 50%

The Junior Members shall be subject to the regular Admission process and once accepted into membership shall have all the privileges and responsibilities of an Active Member and shall be effective upon BOG approval.

Junior Members will have the same rights and privileges accorded to Active Members, and be responsible for a Monthly Maintenance Fee of \$10, and annual Club usage minimums of \$600 per couple, or \$450 if single. Junior Member applicants shall pay an Application Fee of \$50.00. All fees quoted herein shall be subject to applicable sales tax.

### **INTRODUCTORY MEMBERS**

Residents of the Florida Keys who have satisfactorily completed the same admission requirements of Marathon Yacht Club as Active Members, may become a limited term Introductory Member. These Members will have full Club privileges in the Pool, Bar, Dining Room, Ship's Store and Docks. They will not be permitted to vote, hold office, serve on committees, or be accorded FCYC reciprocity. A person or a couple may only be offered this class of Membership one time.

The Introductory Membership shall be for a term of 90 days of the applicant's choice. The fees shall be \$500, which may subsequently be applied toward the Marathon Yacht Club Initiation Fee, provided the Introductory Member elects to join as an Active Member within 30 days of the end of the term. There is no minimum expenditure requirement and no Monthly Maintenance Fees will be billed during the term. Introductory Member applicants shall pay an Application Fee of \$50.00. All fees quoted herein shall be subject to applicable sales tax.

### **BUSINESS MEMBERSHIP**

Any business owner operating within the Florida Keys who wishes to establish Membership for its employees may apply for a minimum of 2 Memberships [i.e., an application to become a Business Owner Member and at least one Employee Member application] to the Marathon Yacht Club. The business owner and each employee must fill out separate applications and all must be approved for Membership in the same manner as Active Members. The Business Owner Member will have the final responsibility for the payment of the employee's account in the event of non-payment by one of the Employee Members.

The fees for the Business Owner Member and each Employee Member shall be 50% of the normal Initiation Fee, and 50% of the Annual Dues. Annual Dues must be paid in full each year. Each Business Owner Member and Employee Member shall pay a monthly Maintenance Fee of \$10, and annual Club usage minimums of \$600 per couple, or \$450 if single. Each Business Owner Member and Employee Member shall have a separate account, separate billing, and each applicant shall pay an Application Fee of \$50.00. All fees quoted herein shall be subject to applicable sales tax.

Each Business Owner Member and Employee Member will have full Club privileges in the Pool, Bar, Dining Room, Ship's Store and Docks and be accorded FCYC reciprocity.

Only the Business Owner Member or the designated Employee Member will be permitted to vote or hold office. Business Owner Members and Employee Members may serve on committees with the exception of the Finance and Nominating Committees.

The Business Owner Member shall have the right to terminate Membership for any of its employees at any time and propose a replacement, who must be approved for Employee Membership in like manner as an Active Member. The terminated employee would be allowed to convert to an Active or Junior Member within 30 days of Membership termination by paying the difference in Initiation Fee and Annual Dues.

## **Marathon Yacht Club**

The purpose of the Marathon Yacht Club (MYC) is to promote and provide unique boating & water sports activities to our members, the local community and the FCYC. As well, our mission is to provide first class physical facilities for dining, social gatherings, education, and dockage managed and staffed by employees who project our values to our membership and guests.

### **Information for Applicants to the Marathon Yacht Club**

The Application must be completed in full, including:

1. Two (2) members as sponsors, with detailed information and/or letters of recommendation. Make sure the sponsors sign the application as well as completing the sponsorship portion.
2. Short biography of member or member/spouse (i.e., Bob enjoyed a long career in financial management, franchising and business ownership. Kathy spent 20 years in sales management for a major electronics firm. They purchased a home on Grassy Key last year and spend at least the four cold winter months here in the Keys. Their interests include gardening, enjoying time with friends and look forward to new friends at MYC).
3. Supply a photo of you and your spouse or significant other. This will be used to introduce you to the membership on our video display and in our monthly newsletter.
4. Complete the data sheet on name tags and membership cards.
5. Enclose your check for \$53.75 (\$50 plus sales tax), which is a non-refundable Application Fee.
6. Please note, your application will be posted for members to view. (process lasts 10 days).

Membership in Marathon Yacht Club does not include a guarantee of dockage. Dockage is subject to availability and the size requirement for the vessel(s) in question.

Marathon Yacht Club is a proud member of the Florida Council of Yacht Clubs (FCYC) and is also listed in the Register of American Yacht Clubs. As a member, you will be entitled to a copy of the MYC Membership Log and provided a copy of the FCYC Register at time of membership. You will have reciprocity with other FCYC Clubs throughout the State of Florida and other Yacht Clubs in the Registry.

### **Membership Eligibility**

- Adults that are twenty-one (21) years of age or older.
- Two (2) active or 49ers members in good standing as sponsors.
- Must provide Monroe County driver's license to qualify for LAMP.
- Must provide proof of ownership of Monroe County business to qualify for Business Membership.

LAMP APPLICATION ADDENDUM

In order to qualify for the promotional initiation fees and annual dues available thru the LAMP program, I (we) hereby certify and understand that:

1. I am (We are) full time Keys residents, and do not leave the area except for occasional trips such as vacations.
2. I am (We are) subject to 50% of full membership initiation fee.
3. I am (We are) subject to the same minimums and full assessments as other members, should MYC have a future assessment.
4. I am (We are) subject to dues increases each year if MYC increases member dues and understand that dues are 50% of the MYC Active Member Fee.
5. I am (We are) eligible to serve on any MYC Committee, with the exception of Finance and Nominating.
6. I am (We are) not eligible to vote in club elections, chair any committee, hold office and shall not have FCYC reciprocity privileges.
7. A LAMP member/couple may convert to Active Membership at any time during the three year term or resign from the Club at the end of the term. Conversion to Active Membership requires payment of 100% of the current prorated annual dues. Should my/our residency cease as full-time Keys residents, MYC must be notified promptly, and my/our dues will be increased accordingly to the Active Membership rate.
8. Any violation of this addendum could result in the membership being referred to the Board of Governors for further review, including increasing dues to Active status or requiring Club resignation.
9. MYC prohibits members from using the docks for personal gain or business use.
