REGULAR MEMBERSHIP

- The required non-refundable Application Fee in the amount of \$100, includes tax.
- There is a one-time Initiation Fee in the amount of \$1,500 payable upon submittal of your application.
- Annual Dues which includes the Annual Operational fee for a total of \$3,100 per year or \$258.33 per month plus taxes.
- There is a food and beverage minimum spend of \$1,200.00 for a couple and \$600 for a single per bridge year and will be billed to your account on an annual basis.
- Should you obtain a boat slip in the SCYC Marina, there will be a one-time Dock Capitalization Fee of \$2,150.
- Regular Membership provides enjoyment of all benefits of the Club, including voting rights, the opportunity to hold office, chairing a committee and the priority use of a Club boat slip when available.
- I/We agree to conform to and be bound by SCYC Bylaws, the SCYC Code of Conduct, and all Rules and Regulations of the Club.
- Florida sales tax will be added to all dues, fees and purchases. I/We further understand that the above quoted fees are subject to change by the Board of Directors.

ALL APPLICANTS MUST SUBMIT THE FOLLOWING ITEMS:

- A complete membership application form
- A copy of their driver's license(s)
- Non-refundable application fee

Once all of the above has been submitted, the following process will take approximately 2-3 weeks. In which case, a credit card must be placed on file with the office to cover any of your food and beverage expenses during this timeframe.
