CSI Saratoga Lake True Crime Stories From Our Home Waters

This is the first in a series of articles describing incidents involving the Racing Rules of Sailing (RRS), how these incidents were handled, and how they **should** have been handled. Each article is reviewed by a number of club members for accuracy, fairness, and bias. Names are not named without the individual's permission. The purpose of this series of articles is to increase the average member's knowledge of the RRS to increase our club's safety, competitiveness, and fun, in accordance with the goals of the <u>Fair Sailing</u> Initiative.

It was a beautiful Sunday early in the season in 2017. I was on port tack headed to windward and approaching a boat on starboard. I ducked behind him. No words were exchanged.

Several minutes later, we had both come about and were again approaching on opposite tacks, this time with me having the right of way.

I hailed "starboard" to no effect. I hailed again. Still the port tack boat held its course. Finally, I ducked astern of her for a second time and hailed "protest", at which point the skipper turned to me and said "we have to stop meeting like this" and sailed on.

Nonplussed by this response, I sailed on with no further comment. As neither boat had a particularly strong finish, I did not follow through on my protest, reasoning that the outcome would make no difference. Instead, I talked to the skipper's Fleet Captain who said he would talk to the individual. As far as I know, that conversation took place and I have had no further incidents with this person.

Let's start the discussion with my big mistake. It is absolutely untrue that a proper application of the rules would have made no difference. Had the offending skipper either ducked me or tacked, I might have finished a place or two better. Had he done his penalty turns after fouling me, perhaps a couple of boats behind us might have done a bit better. Had I taken the case to the protest room and he had been disqualified, *everyone* behind us would have been a bit better off. And as this was one of a *series* of races, in which cumulative results matter, my inaction affected the *season* of everyone behind us.

I gave the offending skipper a talking to, which may have involved some embarrassment. Had I insisted on the proper application of the rules, I might have gotten him disqualified from that race, again only one in a series, one in which he wasn't doing particularly well, anyway. A punishment arguably no worse than a talking to and an outcome that would reinforce the RRS, not undermine them.

So, having hopefully established that the rules do (or at least should) matter, let us review the rules relevant to this situation. First, obviously, we have Rule 10 (R10), a port tack boat shall keep clear of a starboard tack boat. In the first encounter above, R10 was observed. In the second, it was not.

Our next step is to consider the rules about violating the rules. There are two cases to consider, when the offending boat acknowledges the violation and when she does not.


The first case is covered by R44, taking penalties at the time of an incident. Without digging into the two pages of text, R44 says an offending boat may exonerate herself by performing two turns in the same direction, a turn consisting of a tack and a gybe, while keeping clear of other boats. Alternatively, she could take a scoring penalty by flying a yellow flag and informing the Race Committee (does anybody carry a yellow flag at SLSC?). Either penalty, voluntarily taken, is less drastic than potential disqualification after a protest hearing, described next.

Protest procedures are covered in Part 5 of the RRS. Probably most important for the racer to know is R61, protest requirements. Very briefly, the protestor must inform the protestee (ie, hail "protest"), and the protestor must submit his protest in writing. As covered in R64.1, the usual penalty for losing a protest hearing is disqualification.

This and the next few articles are based on my experiences, either as a skipper or a member of the Protest Committee. I look forward to hearing of other sailors' experiences which may find their way into future articles, if other parties' view of the situation can be fairly discovered and represented.

Fair sailing, in all senses of the word.

Sailing School Update

I want to start off by saying Thank You! Thank you to all the members who came to this year's budget meeting and voted in support of the proposal for the Club to assist in the purchase of a new fleet of Flying Juniors. As was mentioned in previous Telltales, the Foundation received a very generous donation from the Alfred Z. Solomon Charitable Trust which funded approximately 3 boats that we would like to purchase. 
