With serious deliberation, the ILYA Board established a three-pronged statement which will lead us in future decisionmaking:

- 1. The Annual Regatta needs to be the premier event of our association each year with regard to the quality of the sailing area, the social events, and the race management.
- 2. The Annual Regatta is the major asset of the association. The ILYA needs to partner actively with the hosting club to assure that expectations of participants are clear and provide assistance, involvement, and support when requested.
- 3. While tradition is important, the future may demand flexibility, and the association needs to be responsive to, and work with, our fleets.

We intend, firstly, to preserve our tradition of providing the best racing

conditions available. We have empowered our fleets to make choices which will promote participation which, in the end, brings us all those experiences we cherish: social experiences, quality of racing, and rekindling of friendships. We welcome our recent initiatives:

- new partnerships (welcome to new member clubs Twin Lakes and Macatawa Bay, and new formats (watch for the A One Design as they sail at Mendota and the Melges 17 which returns to Pewaukee in 2008). Our remaining adult fleets strongly support the traditional format at fun-filled Okoboji.
- new sponsorships (watch for work from Sharon Garber, Fletcher Driscoll, Mark Prange, and Rick Trester)
- new pricing opportunities (C fleet free youth sailing, free registration in all fleets for new boat owners compliments of Melges, and 50% discount in all adult fleets for youth).

The issue date for the circulation data presented here is June, 2007. The total number of copies printed was 1250 and the average for the preceding 12 months was 1238. The total of paid and or requested circulation in June. 2006 was 1180, as opposed to 1175 for the average during the preceding 12 months. Twelve copies of the June issue were mailed at other classes through the USPSI as opposed to an average of 17 during the preceding 12 months. Sixteen copies of the June issue were distributed outside the mail as opposed to an average of 20 during the preceding 12 months. The total distribution of the June 2006 issue was 1208 with 42 printed copies not distributed which totals the press run of 1250. Warning: Classifieds Scam


You may have occasion to use the ILYA Scow Slants or the ILYA Web Site (www.ilya.org) to advertise a boat or related equipment. Evidently some scam artists have found the ILYA Web site and its classified ad page. One of our current advertisers told me he was contacted twice recently with the scam. I heard a similar story from two other ILYA members recently as well.

The scam works something like this (with possible variations): The interested person (scammer) supposedly has a friend or business acquaintance who owes him

money. That money (more than you are asking for the boat) is sent to you in the form of a cashier's check (WHICH IS FAKE!). When you receive the cashier's check, you are supposed to deposit it and send a personal check for the overage amount to the scammer.

Here's how you get taken: The bank has no idea that the cashier's check is fake, so they accept it, and you send a good check to the scammer. After a few days, the bank finds out that the cashier's check was fake, and you are responsible for it. By then you are out your good check, and possibly the boat, if the scammer even bothered to come get it.

You have probably read about this type of scam in your local newspaper. I know it has been



Precautions: Don't accept or deposit any checks without having the bank first verify its authenticity. Tell others about this scam, especially if they may have items advertised somewhere.


ILYA Hall of Fame to induct six at Winter Inland



ILYA sailors Barkow and Ruf prepare for China

Hard work and determination has paid off for John Ruf and Sally Barkow in their Paralympic and Olympic sailing bids. Both are gearing up to represent the US in the 2008 Beijing Summer Olympics.

John has won the opportunity to represent the US in the Paralympics, winning the tight competition in the 2.4mR class. Sally, definitely a favorite in the competition, will know after the midwinter regattas in Florida if she will be the US Yngling entry in the Olympics.

According to Sail Magazine,
"competition for the 2.4mR berth
developed into the closest points
situation of the East Coast classes.
John Ruf (Pewaukee, Wis.) and
Mark LeBlanc (New Orleans, La.)
came off the water tied in points
[on the last day], with Ruf capturing the berth in this singlehanded
Paralympic class on a tie-breaker.
He sailed strong in the second half
of the regatta, winning Race 10
and proceeding to take all bullets
in the next three races. Finishes of
2-2 for Ruf on the final day moved

him from second overall and into the lead.

2.4mR sailor Mark Bryant (Estero, Fla.) finished third, only one point behind the winner. These three Paralympic sailors raced a lethally close contest: at different times during the regatta, each of them held the class lead and only one point separated the top three boats in the final tally."

While Ruf was sailing the Trials, Barkow and her team, comprised of Debbie Capozzi (Bayport, N.Y.), Amanda Callahan (Canton, Mass.) and Annie Lush (Poole, England) exposed themselves to the toughest keelboat competition they could find, and, among a string of achievements, won US SAILING's Rolex International Women's Keelboat Cham-

pionship for the third straight time.

According to US SAILING, "going into the final two races, Barkow led the 39-boat fleet with 14 total points. 'Today we went out and knew what we had to do. It was tricky and light and mind boggling, instead of having to race the boat hard like yesterday. We had to make sure we were in the top eight. Then if we were beating Derby Anderson, we wouldn't have to sail the last race.'

"Barkow finished fifth in the first race and elected not to sail the final race.

"In both the 2005 and 2003 Rolex IWKC, Capozzi and Lush were with Barkow, along with her third Yngling teammate Carrie Howe (Grosse Pointe, Mich.), who could not attend this regatta.

US SAILING Names 2007 Athletes of the Year

Portsmouth, R.I. (December 18, 2007)

US SAILING, the national governing body for the sport, has selected eight athletes as Sailing's 2007 U.S. Olympic Committee (USOC) Athletes of the Year for outstanding performance and achievement. Laser sailor Andrew Campbell (San Diego, Calif.) and Laser Radial sailor Anna Tunnicliffe (Plantation, Fla.) are SportsMan and SportsWoman of the Year; Yngling sailors Sally Barkow (Nashotah, Wisc.), Debbie Capozzi (Bayport, N.Y.) and Carrie Howe (Grosse Pointe, Mich.) have captured the Team of the Year category; Sonar sailors Rick Doerr (Clifton, N.J.), Tim Angle (Marblehead, Mass.), and Bill Donohue (Brick, N.J.) are the Paralympians of the Year.

These U.S. sailors have proven to be dominant forces in their respective one-design fleets in 2007, in both U.S. and international arenas. US SAILING has nominated these sailors to the USOC for consideration for the overall Athletes of the Year awards; each Olympic sport's national governing body selects their outstanding athletes for consideration for this national distinction. The overall winners of the USOC Athletes of the Year awards will be announced in January 2008.

Team of the Year: Sally Barkow, Debbie Capozzi, Carrie Howe

Skipper Sally Barkow and crew Debbie Capozzi and Carrie Howe are familiar faces in the winner's circle of the USOC Team of the Year award: this team competing in the Yngling won this award in 2005, and their outstanding performance in 2007 earns them the title for the second time. These three women have consistently outperformed their peers at class events in 2007 to prove themselves to be a powerhouse team in this keelboat fleet. Their selection

for this award is based on gold and silver medal performances at both national and international events in the Yngling class. Gold medal performances in 2007 included a class win at US SAILING Rolex Miami OCR and the 2007 Princess Sofia Regatta in Palma de Mallorca, Spain; the team brought home silver

medals from the 2007 ISAF Sailing World Championships in Cascais (Portugal), the 2007 Semaine Olympique Française in Hyères (France), and the Yngling North American Championship in Miami (Florida). This team has been named to the US Sailing Team every year since 2003.



Fresh and qualified Race Officers wanted

RUMOR: The ILYA Race Officers and Judges are a small clique of volunteers that do not let anyone new in their little group. WRONG! I also hear over and over that we are a well qualified group that is getting older and older. I can't argue with that. We need fresh blood and new volunteers.

The last complaint about being older also brings with it a great deal of experience. Believe it or not, having a firm grip on the rules and being a great sailor is not all it takes to be a



The ILYA takes considerable pride in the capabilities and skills of its recognized Race Officers and Judges, all of whom are volunteers. In order to establish and maintain a high level of competence within the group, each candidate for appointment is required to meet certain standards of accomplishment, coupled with on-going training and on-the-water experience. Persons seeking these positions are required to qualify as follows:

ASSISTANT RACE OFFICER:

- May be any person who regularly gives of their time and talent to assist in Race Management work at ILYA sanctioned events, either on or off the water.
- Shall be recommended by an officer of an ILYA Member Club.
- Shall be endorsed by an ILYA Senior Race Officer.
- Shall be confirmed by the Race Management and Judges Committee.

RACE OFFICER:

- Shall be recommended by an Officer of an ILYA Member Club and endorsed by the Club PRO or equivalent.
- Should, if possible, have served as Assistant Race Officer (under the supervision of a qualified Race Officer) in at least two ILYA sanctioned events.
 - Shall have two years experience in management of Club or equivalent races including PRO on at least five separate occasions.
 - Shall participate in ILYA Training events or Seminars, on or off the water.
- Shall be endorsed by an ILYA Senior Race Officer.
- Shall be confirmed by the Race Management & Judges Committee.

SENIOR RACE OFFICER:

- Shall have been an active ILYA Race Officer for a minimum of two years.
- Shall have served as RO in four ILYA sanctioned events.
- Shall have served as PRO in at least three events, other than Club or equivalent races.
- Shall have participated in a reasonable number of ILYA Training events or seminars, on or off the water.
- Hopefully participated in a US Sailing seminar on race management.
- Shall have been observed carrying out the function of a PRO, and shall be recommended by an ILYA Senior Race Officer.
- Shall be confirmed by the Race Management & Judges Committee.

JUDGE:

- Shall be recommended by an Officer of an ILYA Member Club and endorsed by the Club Head Judge or equivalent.
- Shall be endorsed by an ILYA Judge.
- Shall have participated in a reasonable number of ILYA Training events or Seminars, on or off the water.
- Shall have two years experience serving as a Club (or equivalent) Judge, including serving as Jury Chairperson on at least five occasions.
- Shall have served as a Judge in at least two ILYA sanctioned events.
- Shall be confirmed by the Race Management & Judges Committee.

RE-CONFIRMATION: Once granted, an appointment as ILYA Judge, Senior Race Officer, Race Officer or Assistant Race Officer shall not be rescinded. However, in order to be considered for selection to serve at future ILYA sanctioned events, each Judge, SRO, and RO shall be subject to periodic reconfirmation by the Race Management and Judges Committee. Principal criteria to be considered by the Committee will include activity and performance.

If you are interested in getting "on track" to be certified in any of these ILYA categories I encourage you contact me during this off season (262-238-1535). I will do everything I can to get you the experience necessary to see if this is "in your blood."

Speaking of seminars or training events, we will be offering two different seminars at the mid-winter Inland. Dr. Tom Hodgson will present a seminar on Judging and I will present a seminar on how to run a race with "time based sailing". Several qualified RC folks will assist me.





Board of Directors meets in Hudson

RULES COMMITTEE/BOARD OF DIRECTORS MEETING

Minutes October 14, 2007 Best Western Hudson House Inn Hudson, Wisconsin

In attendance: Commodore C. Porter, Prange, Trester, Hodgson, Jenness, Haines, Bill Wyman, Andert, Willie Crear (for Catlin), Neuman, Eckert, Sam Rogers (for Bill Fauntleroy), Barkow, Driscoll, Friend, Lamphere, Mann, Osmundson, S. Schmidt, Strothman, Wyman, D. Porter, Reese, Mann, and guests Sharon Garber and Jack Zimmerscheid.

Commodore Candace Porter called the meeting to order at 0900, followed by roll call and introductions.

Commodore Porter discussed several important issues in her Commodore's Report, including the need to face difficult decisions, the strengths of each Board member, the need for a consensual vision and that by working together, we can make decisions we are proud of. She cited for thanks, Beth and Bill Wyman for their extraordinary and tireless work to provide a superb event at the Annual Regatta, and also cited the Pewaukee Yacht Club and their volunteers for a fantastic Opti regatta. Included in her thanks were the chairs and volunteers of all 2007 ILYA regattas.

Noting only a change of date, from 2007 to 2008, (in paragraph 7, in reference to the hiring of a Sailing Director), the minutes of the April 28 Special Board Meeting were approved (Mann, Wyman).

The following actions of the Executive Committee were reviewed and approved (Haines/Schmidt):

- Acceptance of the application of Twin Lakes Yacht Club for club membership.
- A new framework, and voting status on the rules committee for X and Opti Class Committees.
- 3. Melges 17 Championship trophies were accepted.
- 4. Approval of the date for the X championship: July 23-26.
- 5. Discussions with Mendota Yacht Club regarding A, I-20 regattas were initiated
- 6. A request from Brad Robinson regarding *Victory* was deferred to the A One Design national organization, as the issue related to scantlings, which is the responsibility of NCASA.

Commodore Porter led a lively and far ranging discussion on the topics raised at

the Delegates' Meeting held October 13, 2007. Among the topics discussed were continuing the 50% discount to youth sailors, enhanced live reporting online from regattas, youth championship issues, and a report from Sam Rogers of Melges Performance Sailboats.

Commodore Porter and Vice Commodore Prange then led the board in a discussion of promotion, aptly titled, "Winds of Change." The discussion centered on regatta site selection, regatta programming, race management, and the role of the fleets in the aforementioned topics. After considerable discussion, three points of consensus emerged:

- 1. The Annual Regatta needs to be the premier event of our association each year, with regard to the quality of the sailing area, the social events, and the race management.
- The Annual Regatta is the major asset of the association. The ILYA needs to partner actively with the hosting club to assure that expections of participants are clear and provide assistance, involvement and support when requested.
- 3. While tradition is important, the future may demand flexibility, and the association needs to be responsive to, and work with, our fleets.

These points were reviewed and, while no action was taken, Commodore Porter asked for, and received, general consensus on all points. Vice commodore Prange and the Regatta coordinating committee were directed to develop a tentative five year plan for the ILYA championship(s). Jack Strothman recommended that the plan be available at least a month prior to the Winter Inland for broad comment by membership.

Chair Mann gave the Race Management and Judges Committee Report, which was prefaced by praise and thanks by Commodore Porter directed to Chair Mann and all in the race officer corps and the regatta volunteers. The report included regatta reports from all the PRO's for all ILYA events in 2007. Mann cited the lack of judges (jury chairs), and the Board offered suggestions. Time-based sailing was discussed, and approval from all fleets will be sought at the fleet meetings for action (adoption) at the Winter Inland. Other nonaction items discussed included recruitment of younger race officers, sailing instructions be available to fleet reps for review before the event, and that the fleets should work with RC and regatta organizers to assure sufficient safety boats.

Fleet Reports:

Class A Open: Jenness reported that the fleet would like to hold its 2008 Invitational on White Bear Lake. The experimental hull program (*Innovation*) will continue. The Rules Committee approved the use of carbon fiber bilge boards on an experimental basis for the Jenness boat. The boat will be scored during the experimental period. (Jenness/Driscoll).

Class A One-Design: Haines reported that the class is healthy, and that Melges Performance Boats potentially has 3-4 new orders, pending sale of existing A-boats.

Class E: Wyman announced that Lon Schoor will serve as Secretary of NCESA and noted that the asymmetrical spinnaker issue is still pending. The fleet prefers its regattas to be held over the weekend, if possible, and has approved time-based sailing.

Class C: Andert gave regatta reports and notes from the national association. He proposed motion to approve anodizing of bilge boards and rudders, which was passed by the Rules Committee, and also passed by the full Board (C. Porter/Jenness). Through a cooperative effort between the national class and the ILYA promotion committee funds, C events will be free to youth sailors next season.

Class Inland-20: Crear (for Catlin) gave regatta reports, and read a line from Inland-20 National Association Commodore Joe Terry, noting that the general perception of the I-20 fleet is that they get very little for their money from the ILYA. This generated a lively discussion of the relationship of the I-20 fleet (and its national association) to the ILYA. Crear was charged with obtaining an Invite site and to discuss his fleets concerns regarding safety boats. The fleet was charged to assist with safety boat coverage if the fleet is in need of extraordinarily high coverage.

Class M-16: Eckert noted the participation at the 2007 Annual Regatta (19 boats) was healthy, but expressed concern about participation in the 2008 Annual and Invitational regattas. She reported that the M-16 Scow Sailing Association is interested in taking over control of the class scantlings. She moved that the number of trophies at the Annual Regatta be increased to five, based upon recent regatta attendance (Eckert/Reese). After discussion the action was tabled.

Bentsen, Pegel honored

At a reception held at the Chicago Yacht Club in August, ILYA members Bill Bentsen and Bob Pegel, both from Geneva, were recognized by US SAILING for their long and distinguished service to the sport of sailing. The title Judge Emeritus was bestowed on the pair.

Bentsen served for many years as chairman of the Rules Committee and Appeals Committee and played a major role in the development of the Racing Rules of Sailing which are used world wide. An accomplished sailor, Bentsen won an Olympic bronze medal in the Flying Dutchman class and a gold medal in the Soling class. Bentsen has always been available to ILYA race committee and judges for expert advice, and secured ILYA assistance in the experimental use of the current simplified racing rules.

Pegel served as a Senior Judge, Senior Race Officer, associate Appeals Committee member, chairman of the Race Management Committee and the US Single-handed Championship. He was instrumental in writing the rules used in iceboat races around the world. Pegel's achievements in racing came via the E Scow, in which he won a Blue Chip regatta and placed as runner up in several ILYA and NCESA championship events. On the ice he has won Northwestern and International Skeeter Class titles. Pegel continues to serve on race committees and juries at the Lake Geneva Yacht Club and in ILYA sanctioned events.

Happy Tenth Anniversary

or is it the 110th anniversary of the Inland 20 Class?

The I-20 Class is celebrating its tenth anniversary in 2008, but actually has roots going back to 1898, when the tunnel-hulled DOMINION dominated the Seawanhaka Cup competition between Canada and the U.S. scow clubs. Later came the M-20, introduced by Harry Melges, and promoted by his son Buddy and 'Smiley' Freytag through the '60s and '70s. The current design, the I-20, is a further improvement on the M-20, the principal difference lying in the asymmetrical spinnaker flown on a carbon fiber sprit, with carbon fiber spar, which makes this 20' boat fast, fun, and safe to sail. The components are so light it is a simple affair for one person to rig.

What is unique about the I-20 is that the class started with one boat, and a long history. The ILYA Class A scow was the first to convert as a group to the asymmetrical spinnaker rig in 1994, followed by the I-20 introduction in late 1997. With a vote looming, it

appears as if the National E Scow Class will follow the lead of the A and I-20 in 2008 or 2009, and convert to asymmetrical spinnaker as well. The M-20 and Inland 20 set the stage for this evolution of one design scow sailing as we know it.

From humble beginnings in Madison, Wisconsin and a new builder in Windward Boatworks, the class has grown to a sizable organization, running regattas and continuing to grow fleets across the Midwest and the rest of the country. Our newest growth has been through America's heartland, with new energy and boats at Lake Wawasee, Indiana; Lake Carlyle, Illinois; and Indian Lake, Ohio. This region of the Midwest is an untapped resource for growth of scow sailing. The I-20 is gaining a firm hold as new boats and better sailors swell the ranks. Old blood hears the footsteps of new blood, with sailors from Lake DuBay and Carlyle, not traditional I-20 or M-20 lakes, winning two of the four

national events this past year.

Within the ILYA, the class has added more boats up and down the shores of Lake Winnebago. From Neenah to Fond du Lac the numbers keep growing. After this year's ILYA Championship at Oshkosh the fleet remarked at how great it would be to have the ILYA live in Oshkosh, at its once and future home at the foot of Washington Avenue. This is a great compliment to OYC, and is a reflection of the amount of I-20 sailing activity in the Fox Valley. Today we stand as the strongest one design scow class in that area. The Class has turned Lake Winnebago into an I-20 lake, with three clubs regularly sailing I-20s: Neenah-Nodaway, Oshkosh, and Fond du Lac.

Up to the north the Minnetonka sailors have become energized with the rebuilding process that is happening on their waters. As new boats make the journey that way, people are seeing first hand what many have known for a long time: the I-20 is the best bang for your racing dollar and time.

In ten quick years, we have come a long way, with a lot more to accomplish. The tenth year anniversary celebration and National Championship is scheduled for Green Lake, September 26-28. This will illustrate to all sailors what good leadership and a little hard work can accomplish. The Green Lake YC is excited to have us. and the I-20 class has long enjoyed sailing these waters, with more I-20 events having been sailed there than anywhere else. In addition to the sailing, three days of festivities will make this event one to be remembered. The goal of bringing 50 boats to this event has everyone excited and with help from all, it will happen.

We look forward to seeing all those who have been involved with the class from its inception to today. Thank you for your contribution in making the class grow and leaving a legacy of fun family sailing for all to enjoy.



National Commodore wins first event—ILYA I-20 Invitational

Sailors representing Wisconsin, Illinois, Missouri, Indiana, and New York met in Fond du Lac, Wisconsin on the south shores of Lake Winnebago for the Inland Lake Yachting Association's (ILYA) Inland 20 Scow Invitational.

Fifteen teams made up the class hosted by the Fond du Lac Sailing club for racing on Saturday and Sunday, June 23rd and 24th. With most of the teams arriving on Friday evening, a great time was had setting up boats and catching up with friends in beautiful Wisconsin summer conditions.

As the boats were prepped and splashed, the winds started filling in toward the forecasted 9 mph from the southeast. While the wind conditions were a little lighter than what most of us prefer in the high powered Inland 20, the highly adjustable rigs were tuned to be powered up in the lighter stuff and the sailors skimmed over the flat water unusually smooth for lake frequently called "Windybago."

Race 1 began on a very short starting line with everyone starting cleanly. My wife LaCinda and I liked the winds up the center of the course and while the pin end seemed preferred, we chose to try to start on the right side of the line. We made a nice hole and hit the line for a great start at full speed and quickly worked our way up the middle of the course. The winds were nice, and we kept our Inland 20 on it's lines with firm mainsheet tension, a touch of vang, and some backstay when the puffs filled in. In fact, we were working the backstay more than the mainsheet on the first beat.

The good start paid off as we rounded the first windward mark in first place. The fleet as a whole sailed pretty tight and the downwind leg was challenging. Choosing speed vs. angle can be a tough decision and while we opted for speed early in the leg, as the wind diminished slightly, we started working deep. We rounded the leeward mark still in first place, but found some holes on the second leg that George Winter and John Hayashi avoided and we took a respectful second place.

The winds dropped to next to nothing for the second race. We got off to an awful start when we found ourselves between a barging boat and a luffing boat and became the double crunch between two scows. Fortunately, the Inland 20 was built to take a beating

and no damage-not even a mark-was left on the boats as the barging boat tacked away for penalty turns. Unscathed, but way back in the fleet, we had our work cut out for us. We worked our way back toward the middle of the fleet when the wind all but died. On the

last downwind leg of a W 2 1/2 in nearly zero wind, we opted for a wildly unconventional sail plan—we dropped our main so we could use the asymmetrical to head dead toward the mark. While we wouldn't necessarily recommend this practice, it was effective in a couple of ways: First, we managed to make our way back into the top five boats by keeping the chute filled in nearly no wind; and second, after some refreshing beverages later that evening, everyone had quite a few laughs when we all agreed that no one can remember any scow sailing a downwind leg without a main sail, and catching up with the

The racing was called after two races due to no wind, and at the end of day one, we found ourselves tied in second place with Stefan Schmidt and Juan Gonzolas with a very tight field of very good sailors behind us.

Sunday's forecast didn't look good, and there wasn't much hope early in the morning, but the big lake became its own weather machine, and while the forecast called for 5 mph southeasterly winds, the lake produced it's own 5 to 8 mph northerly.

The boats splashed after a short postponement and race three was underway. Once again there was a very close and clean start and for the entire regatta, there were no individual or general recalls. Our objective was to protect our second place ranking as first seemed quite optimistic, so we worked hard to keep in contact with the contending boats. The winds were spotty, resulting in a lot of hunting going on. We managed to stay with the leaders, and by the second windward leg rounded in



first place just in front of Grant Frautschi and Carolyn Curry. We rounded the last leeward mark again a few boat lengths ahead of Frautschi and Curry and because our primary competition was a few places back, we kept our distance and worked together with Frautschi in attempt to gain some insurance on the rest of the fleet. We were excited as we approached the finish line a few boat lengths ahead of Frautschi, but whom did we see coming in on starboard—youngsters Steve Catlin and Andrea Gratton! We were about to cross clear ahead when we were stopped dead by some chop generated by a huge power boat. We got our tack in, laying the finish line, but Catlin and Gratton had just enough speed to sneak across the line about a foot in front of us and take the bullet.

The time limit came after one race on Sunday, and when the scores were tallied, our consistency paid off; for the first time ever, LaCinda and I brought home the first place trophy. And while we're extremely proud of the accomplishment, what is truly unique is that until this year, we've been the lone Inland 20 on our lake. The only one-design experiences we have had are traveling to ILYA and National Inland 20 Scow Association regattas over the years. So the people we really have to thank for our victory is the rest of the Inland 20 fleet. It's those sailors—and you ALL know who you are—who have unselfishly dedicated themselves to bettering the fleet as a whole, who have shared their "secrets,"—rig setup, sail trim techniques, tactical suggestions, etc. so the rest of us have been able to get up to speed and be competitive.

It was a proud and memorable



Class MC: Neumann requested a clarification in the sailing instructions regarding the ability of a race officer to either finish a regatta before the last day of scheduled sailing, or potentially add races under uncertain weather conditions and forecasts. After discussion, it was suggested that the fleet committee make a proposal to the Board at the Winter Inland. He then reported on regatta attendance issues, and noted that the fleet endorsed time-based sailing. Commodore Porter challenged Neumann to consider promotional efforts to assure increased participation after this year's poor attendance.

Class Melges-17: Rogers (for Fauntleroy) reported on recent regattas and reflected on the success of last year's events. He requested that the 2008 championship again be awarded to Pewaukee (and separate from the Annual Regatta), noting with Commodore Porter the number of Melges-17 sailors who sail in other classes. The fleet endorses time-based sailing. Rogers went on to express the appreciation of the class to the ILYA and related benefactors for their support, and especially for the magnificent trophies now awarded to the class.

Class X: S. Schmidt (for Murphy) recommended holding off on site selection for the 2009 and 2010 Championship Regatta until the Winter Inland. The potential bidders will be asked to attend to promote the sites.He noted that the new deck design approved last year has been well-received, and offered praise to RM&J Chair Chip Mann for his leadership in time-based sailing, something the X class is using to great positive effect.

Optimist Dinghy: Reese led a discussion of cross-region regatta attendance. On her motion, the Rules Committee approved that our Green Fleet Championship be expanded to two days (Reese/Jenness). She offered praise and congratulations to Sharon Garber and the Minnetonka Yacht Club's regatta committee and volunteer corps for the 2007 Opti Championship, noting (to applause) the sponsorship and volunteer ethic, illustrated by the distribution of 13,000 bottles of water during the event.

Rules Committee Chair Lamphere then noted some items currently under discussion that may have proposals by the Winter Inland meeting:

- 1. Defining what a "sanctioned class" means in our bylaws.
- 2. The need to explore masthead or sail peak floatation.
- 3. The implications of a 5-year measuring rotation among classes.

- 4. How many races constitute a regatta.
- 5. Requests from the Inland-20 and M-16 classes to take control of their scantlings.

Prange reported for the Regatta Coordinating Committee. The following actions were taken:

- 1. 2009 Annual Regatta: Awarded tentatively to Green Lake (Mann/Jenness).
- 2. 2008 Annual Regatta schedule was discussed, and will be resolved by the Executive Committee by November 1.
- 3. A One-Design: 2008 Awarded (with 2 abstaining) to Lake Mendota (Haines/Schmidt).
- 4. Inland-20: Made no request to move the 2008 championship venue to Mendota. Given that the class committee chair (Catlin) had previously requested to move the I-20 championship site from Okoboji to Mendota, the Executive Committee was authorized to check once more with fleet leadership to assure that the correct site was scheduled. (Subsequently, upon further discussion with Catlin, Okoboji was selected for the 2008 site).
- 5. M-16: Would like their championship regatta to be held at Lake Okoboji with the other fleets of the Annual Regatta.
- 6. Class C: On a motion by Andert/ Mann, the 2009 Invitational was awarded to Lake Minnetonka, and the 2010 Invitational to Lake Beulah.
- 7. Optimist Dinghy: A Reese/Trester motion to award the 2008 No Tears East regatta to Lake Beulah, and the 2008 Optimist Championship to Cedar Lake was approved. It was noted that a bid is still needed for the 2008 No Tears West regatta.
- 8. A Prange/Trester motion to award the 2008 ILYA Youth Championships to Lake Mendota, specifically the Hoofers, was approved.
- 9. The schedule for Okoboji will be set by Okoboji and the EC to be announced by November 1.
- 10. By general consensus the Melges 17 event will be held at Pewaukee.

Trester presented the Finance Committee report, noting that an operating loss was expected for the fiscal year and the cyclical nature of ILYA budgets based upon regatta location, attendance, and other factors. Advertising rates in *Scow Slants* and the revenue potential of our online presence was discussed. A subcommittee of Driscoll, Sharon Garber, Wyman, and Prange was charged with looking at expanding our advertising revenues and developing a tem-

plate for adverting rates and availability, etc., at regattas, online, and in *Scow Slants*.

Reese and Porter reported that the Promotion Committee is working to enhance our online presence, and will present a comprehensive report at the Winter Inland.

Commodore Porter reported that Youth Development has a number of things in the works, and will defer their report to the Winter Inland. Aaron Mann has been selected as chair. The ILYA Youth Champs will be held again at Hoofers with addition of parental supervision to the regatta organization.

Reese reported that the Winter Inland will be held on February 8-10, 2008, at the Olympia Resort in Oconomowoc, Wis., and will feature an Olympic Games theme, honoring John Ruf and Sally Barkow. Expenses and the investment in the Winter Inland was discussed at some length.

Barkow displayed, to unanimous approval, the new trophies. She reported that a savings of over \$2000 has been realized. Requests from several clubs and sailing entities have been made for the digital images, and a discussion followed as to the ownership of the image and our role in potentially selling or making those images available. Barkow suggested that the responsibility for maintenance of perpetual trophies is currently undefined, and needs study and future action. Also for future study is the issue of how many trophies per fleet should be awarded, and how that number should be determined. Barkow will, with the help of the Executive Secretary, prepare a list of needed repairs for 2009.

Old Business: Trester reported on the continuing upgrade of our online registration and membership processes. Online credit card processing is coming.

New Business: Commodore Porter noted the Olympic Campaigns of Sally Barkow and John Ruf, and asked for the approval of the Board for the Executive Committee to do some planning around how the association might support these campaigns. The date of June 7 was suggested as a date for an official send-off for John and Sally. While there was no official action taken, there was no objection raised to Commodore Porter's request.

A motion to adjourn (Wyman/Friend) was approved, not by voice vote, but by the overwhelming sound of chairs being moved away from the meeting table.
