




When I wrote the history of the Inland Lake Yachting Association, one of the most powerful themes that spoke to me was the extent to

which events that connect us transcend the generations. It's something deeper than tradition or heritage, because of the intense connection to people and families.

You could take any moment in our Association's history, and connect ILYA families to it. The development of the E Scow is one example of these six degrees of separation. The Meyer and Friend families-so instrumental in bringing the E Scow from concept to reality in the ILYA-are still active in scow sailing today. Peter Friend is the E Scow class committee fleet representative. The children of Pine Lake's Leslie Friend Barkow sail all over the inland and the world...and Pine Lake was the recipient of one of the first E Scow prototypes built by Johnson Boat Works in 1925 at a cost of \$750.



The dramatic emergence of an A scow fleet at White Bear is yet another example. White Bear was, of course, where John O. Johnson built his first scow to the measurement rule that would ultimately become Class A. An integral member of the refitting and sailing team for Fletcher Driscoll's fleet of A boats is Steve Johnson, Johnny Johnson's grandson. Another A boat in the White Bear fleet is owned, in part, by Jason Brown, stepson of Iver "Skip" Johnson, another Johnny Johnson grandson. That boat is moored at the home of Jock Irvine, long time ILYA race officer. Jock is the grandson of ILYA champion and Hall of Fame sailor Jack Ordway, great-grandson of Lucius Ordway, the ILYA's first A-Scow champion and nephew of former commodore Smokey Ordway, who is hosting the Friday night party for White Bear's coming A regatta.



Recently, at the Northern Bilge Pullers banquet, I got to chat with Jerry Huse and Boober Schneider, who were up to enjoy the dinner and sail in the Upper Tuner Upper hosted by the Upper Minnetonka Yacht Club. What a joy to be in the presence of these great C sailors, who share seven ILYA championships between them, with many more Invitational and Interlake championships as well. When the first ILYA Yearbook was published in 1957, Jerry and Boober were already sailing together on Okoboji-that's almost a half century—about half the time that C scows have been an ILYA fleet. I hope all C-boaters are gearing up for 2006, the 100th

anniversary of C Scow sailing in the ILYA! I know that Boober and Jerry will be there.



Every lake and every fleet in the ILYA has stories like this, and there are many families that can trace a sailing heritage back to when we measured boats by the Seawanhaka rule. Three-generation sailing families are so common on our lakes that we could fill a page in *Scow Slants* simply listing them.

When I reflect on the remarkable extent to which we are connected to our sailing past, and to each other, I can't help but feel a part of something important, a whole that is bigger than the sum of its parts. All of us—our members, our boats, and the traditions of this association—are so deeply interwoven that we are truly a family in scow sailing.

What's new in the sailing instructions

The first thing you'll notice is the "SI and NOR Disclaimer." The language used in the Inland SIs was basically developed by the ISAF and modified to accommodate our junior sailors. The "Disclaimer" is an

important minder to every sailor that he or she is responsible for deciding whether or not to race.



Every ILYA class has its own defined guidelines and the Race Committee has to take these and other factors into account when deciding whether or not to race or continue to race. Once a race is started, as PRO I'll ask myself, "Is this a safe race?" and "Do I have control over the race?" If the answer to both questions is yes, then I'll allow it to continue. If not, I'll abandon it.

When the position of the next mark is changed, the ILYA will continue to use similar marks for the new mark as for old mark. When both new and old marks are present, the new mark will be identified by displaying the FI on the RC mark boat near the new mark, if practical.

For the junior and youth regattas, the RC will use red and green flags or shapes to define the direction to the new mark in accor-



dance with RRS 33(a)(2). For all other regattas, the RC will continue to hail and broadcast the compass direction to the new mark.

When a race is to be finished downwind by shortening the course at a gate, one of the gate marks will be replaced by an RC boat and the finishing line will be between that RC boat and the nearby mark. Boats which have been lapped or are about to be lapped shall treat the RC boat and the nearby mark as gate marks.

Finally, we've added the words "believed to be" to SI 24 to insure that safety is our primary concern. If you are a support or coach boat and *believe* that you see somebody in distress, you are permitted to enter the racing area to investigate the situation and render assistance if necessary.

If you want to review the new Sailing Instructions, they are posted on the ILYA web site.

Sherin introduced a small but eager group to the wonderful world of Race Committee work. Our thanks to the LBYC and especially ILYA Vice-Commodore Candace Porter who had a pot of hot coffee ready when we arrived.

Another workshop is planned for 2006. It will probably be an on-thewater event in conjunction with the Cedar Lake, Wisconsin Spring Regatta. Watch this column for further information.

Board of Directors hold May meeting

Minutes May 18, 2005 Courtyard Madison East Madison, Wisconsin

The meeting was called to order at 1:52 p.m. by Commodore Hodgson. The following directors were present: Hodgson, C. Porter, Prange, Harken, Burns, Haines, Friend, Pinahs, Catlin, Colburn, Kaiser, Barkow, Jewett, Lamphere, Mann, Schmidt, Slocum, Trester, and Wyman. Rules Committee At-Large members D. Porter and Baker were present. Class IOD representative Reese was present. This represented 100% attendance. Attorney Darryl Bell from Quarles & Brady was present.

All present introduced themselves. Hodgson made opening remarks as did Bell.

The minutes of the February, 2005 meetings were approved unanimously as published (Trester/Harken).

Actions taken by the Executive Committee on behalf of the Board were approved unanimously as follows: Approval of ILYA Regatta registration waivers and approval of emergency office rent, if needed, of up to \$500 plus utilities (Mann/Catlin). Approval of contract for counsel with Darryl Bell of Quarles & Brady at \$300 per hour and Bell's responses to letters from Windward Boatworks' attorney and Brad Robinson's attorney (Catlin/Schmidt). Approval of decision to willingly accept donations made to the ILYA general fund, but not to accept donations specifically earmarked for legal defense (Slocum/Barkow). In discussion of an Executive Committee action limiting awards in the 2005 Class A Championship to the top three boats instead of the top five, the action was rescinded and the Board was directed to use the donation which was made to make up the difference (Mann/Catlin).

Hodgson turned the meeting over to Trester for Rules Committee business. Smith reviewed the meeting protocol and voting procedures.

Trester reminded the Committee that the revised scantlings for classes C, M, and X were approved at the February meeting. The revised Class A scantlings were tabled to this meeting for various reasons including the accidental omission of the bow sprit and spinnaker pole rules, and the status of the Melges 2004 mold. Trester moved and Catlin seconded the following changes to rules 83.2.a, 86.2.a, and 80.4.a as follows:

83.2a General. The shape of the hull of the yachts built after October 18,

2003 shall be in accordance with the digitized C scow shape held by the ILYA Executive Secretary. The allowable +/- tolerances for this digital shape shall be 10mm. Any hull previously built from a fiberglass hull mold in existence prior to October 18, 2003 shall be considered qualified. 86.2a General. The shape of the hull of the yachts built after October 18, 2003 shall be in accordance with the digitized X scow shape held by the ILYA Executive Secretary. The allowable +/- tolerances for this digital shape shall be 10mm. Any hull previously built from a fiberglass hull mold in existence prior to October 18, 2003 shall be considered qualified.

Class C and X

80.4a When any existing mold is modified in any way that changes the hull shape or when a new mold is made, and prior to sale, the first boat out of the modified or new mold will be measured using a laser inferometer (or a like technology which has been approved by the ILYA Rules Committee Chairperson). The digital image from this measuring will be compared to the original measurement held by the ILYA Executive Secretary to insure that it meets the specifications of the class. Representative spars, rigging, bilgeboards or centerboard, rudder and any other relevant equipment to be furnished which is covered by these rules will be submitted to the ILYA Official Measurer for approval in accordance with ILYA scantling and measurement rules. The party presenting the item(s) for measurement (i.e. the boat manufacture) will be responsible for all costs associated with the measurements and comparisons.

Class Inland A and M

80.4a When any existing mold is modified in any way that changes the hull shape or when a new mold is made, and prior to the sale of new yachts utilizing the new mold, a boat manufacture must submit the hull or the mold or the plug together with representative spars, rigging, bilgeboards, rudders or rudder, and any other relevant equipment to be furnished which is covered by these rules to the ILYA Official Measurer for approval in accordance with ILYA scantling and measurement rules. The measurer shall provide the specifications in each class which should apply to its respective plugs.

(i) No change

b. A Builders Certificate of Measurement (Form 5) shall be issued to a builder for each form or mold approved by the Official Measurer. Any change in the plug or the mold shall require a re-measurement and the issuance of a new certificate.

d. Drop

An amendment to the motion was approved as follows (Trester/Catlin): The Rules Committee is directed to get recommendations from the digitizing company as to how to word our scantling tolerances to use baseline or zero pointing to eliminate any chance of the doubling of tolerances. A second amendment to the motion was approved unanimously as follows (Burns/Kaiser): The Rules Committee is directed to submit the final wording for these rule changes to the Executive Committee for final approval before June 15. The original Trester/Catlin motion was then approved unanimously.

Class A Scow scantling issues were discussed. Regarding the language on bowsprits and spinnakers poles which had been inadvertently omitted in the process of updating the organization of the Class scantlings, the following motion was approved unanimously (Burns/Baker): All language relating to Class A bowsprits and spinnakers from the 2004 General Scantlings section of the Rule Book are to be transferred to the Class A specific scantling rules.

The Class A specific scantling rules (Section 81) as presented in February were then approved unanimously with the removal of the reference to the 2004 Melges A Scow mold (Burns/Haines). Thus, rule 81.1.a) reads as follows: "All Class A Scows built after October 18, 2003 shall be of strict one-design based on an ILYA approved mold shape defined as the Melges Boat Works mold as of January 1, 2000. All ILYA certified boats prior to February 2004 shall be grandfathered." The intent of the removal of this language was not to reject the current mold, but the issue was deemed moot for the 2005 season and discussion was becoming too lengthy. In consideration of the lengthy agenda facing the Board, the discussion was deferred since no one has purchased a boat from this mold and the NCASA will likely approve the boat. It is unlikely that the boat would appear on the water for the 2005 season. The issue will be revisited.

LATE SPRING 2005 Our Sally and teammates win again!

US Sailing Team-members Barkow, Capozzi and Howe Win Semaine Olympique Française

US Sailing Team members Sally Barkow (Chenequa, Wis.), Debbie Capozzi (Bayport, N.Y.), and Carrie Howe (Grosse Pointe, Mich) won the Yngling fleet at Semaine Olympique Française today [April 29], an ISAF Grade 1 event. The competition at Hyères proved to be a nail-biting experience from start to finish for Barkow's team, the only Americans competing in the all Olympic-classes event. Throughout the regatta, the competition in the Yngling fleet was close, and Barkow's team was in the top two the entire time, trading the lead several times with the British team skippered by Olympic gold medalist Sarah Ayton.

The final day of racing turned out to be the most exciting of all when event organizers 'piloted' the Grand Final: after

the last race of the day was completed, a Grand Final was to be sailed by the top three Yngling boats in overall rankings (USA, GBR, and RUS). In the Grand Final, the three boats would sail races until one of the boats won two races and that boat would have been named the ultimate winner. However, after three Grand Final races, each Yngling team had won one race and the deadline in the Sailing Instructions didn't leave enough time for a fourth race to be sailed to determine a winner. Since Barkow's team had won the regular fleet racing event, they were declared the winning team.

This is not their first victory of the year - they won US SAILING's Rolex Miami OCR in January, and are currently the top-ranked Yngling on the 2005 US Sailing Team. Fresh from their most

recent win, they will travel to Riva del Garda, Italy, for the Yngling Revival and Expert Olympic Regattas in early May.

The US Sailing Team is managed by US SAILING, national governing body of the sport. Headquartered in Portsmouth, Rhode Island, US SAILING's mission is to encourage participation and promote excellence in sailing in the U.S. US SAILING offers training and education programs, supports a wide range of sailing organizations and communities, and provides administration and oversight of competitive sailing across the country, including the US Sailing Teams and the U.S. Olympic and Paralympic Sailing Teams. The Rules Committee then discussed a proposed procedure for new builders. An amendment to a proposal was approved with one nay vote as follows (Trester/D. Porter): The prospective builder must agree to use a five axis milling machine to produce the plug without alteration of the digital shape. Further discussion resulted in many additional changes to the original proposal by consensus, and the following motion, adding a new paragraph d to rule 80.4 eventually emerged and was approved unanimously (Baker/Catlin):

80.4 Builder requirements

Any boat builder seeking a certificate of measurement in any ILYA class for which the ILYA holds the digital shapes shall follow the following procedure: Send a written request to build specific classes to the ILYA Secretary a minimum of 90 days before a regularly scheduled ILYA Board of Directors meeting. This request should include the following information:

 Classes that they wish to build and digital shapes they request from ILYA.
 Evidence that the builder is capable of using the digital shapes and then building to our scantlings.

a. Prospective builder has access/relationship with provider of laser inferometer equipment.

b. Prospective builder commits to use a 5-axis milling machine to produce a plug without alteration of the digital shape.

c. Prospective builder has access/relationship with provider of spars that meet the extrusion shapes and tolerances defined by the scantlings.

Upon receipt of the request the ILYA Secretary will schedule a meeting between the proposed builder, the Class Committee(s) of the appropriate class(es), and the ILYA Executive Committee to allow the proposed builder to present his or her request in detail. After this meeting the request will be presented to the ILYA Board of Directors. If the builder is found to meet the criteria in item 2 above, and pending payment of access fees, if any, and absent any reason for the Board to deny it, the Board will provide the digital data to the builder.

The Rules Committee then discussed a range of fees that could be associated with the application of a new builder and measurement of a new builder's product. It was

unanimously approved that the fee for access to the digital shapes in Classes C or X would be \$5,000 and that the subsequent fees will be payable by the prospective builder which may include the fee for digitizing the first boat produced, the fee for comparing the data obtained from the first boat to the original data and determining whether the data was within the allowable tolerances, and the fee for measuring the deck, spars, rudders, etc. would be based on the actual cost of such services submitted by the providers that were authorized by the ILYA to provide these services (Haines/D. Porter).

Article 10.15.B.5 was approved unanimously to read as follows (Trester/Haines): Class Committee duties: Recommendations for changes in Class Scantling Rules shall come before the ILYA Rule Committee and the Board of Directors only after such suggested changes have been favorable voted on at the Class Meeting at either the Annual Championship or the Midwinter meeting. Any changes voted on at the Midwinter meeting will not go into effect until the Fall Meeting of the same year. Results of this vote will be forwarded to the Class Committee, then to the Rules Committee and used as a basis for its recommendation to the Board of Directors.

By consensus the Rules Committee confirmed that Class M rule 85.5 does not preclude an owner from replacing a rudder with a new rudder of the same type should one or more be broken or damaged or worn out. A motion (Kaiser/D. Porter) was unanimously approved to remove the requirement that Class M 'rotating masts must have been built prior to January 1, 1999' from rule 85.15.a.2.b. to read as follows: "Rotating aluminum masts may only be used on hulls built prior to January 1, 1999." A motion (Kaiser/Trester) was unanimously approved to add the 1997 Class M scantlings to the existing class scantlings so that a builder could build a new boat to either one set of scantlings or the other, but not a mixture of both.

Pinahs reported that the Class C Fleet Committee with some limited input from the fleet members would rate construction quality as a major factor in considering new builders.

There being no further Rules Committee business, the Board meeting resumed under the direction of Commodore Hodgson. The recommendations of the Rules Committee were then approved unanimously by the Board (C. Porter/Prange).

Under Old Business, the Executive Committee presented its proposal regarding scheduling of Class A regattas in 2006 and beyond. This proposal failed to receive a second. Other proposals were suggested, including one from Lamphere. After lengthy discussion, the following motion was approved unanimously with no abstentions (Mann/Burns): "The ILYA Board supports the 'Lamphere' option #2 or some mutually acceptable language as a tri-party signed agreement on or before June 1 at 5:00 p.m. CDT or Lamphere option #1 will go into effect automatically and immediately (Mann/Burns). 'Lamphere' options #1 and #2 follow:

Option #1

The ILYA will, until such time as an agreement is reached, disband Class A Scow racing in its regattas for both the "Box Rule" and "NCASA Rule" A Scows. During such period, these fleets shall be deemed inactive and Fleet Representatives from these will no longer sit on the ILYA Board. The Association can return to the mission of promoting scow sailing and cease losing money on poorly attended regattas and spending money as a result of threatened litigation.

Option #2

The ILYA, Bradley Robinson, and the NCASA enter into a tri-party agreement under the following terms:

1. The parties agree that the ILYA should establish an ILYA "Box Rule" Class A class and an ILYA "NCASA Rule" Class A class.

2. Both Classes will race in the Annual Championship regatta. These races may, or may not, be on the same course, or even on the same dates. However, it is specifically agreed that if these classes race on the same course, the start times will be staggered by at least five minutes.

3. The ILYA will amend the "Hudson Agreement" with Bradley Robinson to allow him to build an unlimited number of new boats to compete in the ILYA "Box Rule" A Class.

4. The ILYA agrees that "Box Rule" A Class and "NCASA Rule" A Class regattas will not be discontinued due to a lack of attendance

for a period of five years. 5. The ILYA and Bradley Robinson agree that the rules for the "Box Rule" A Class will revert to the pre-Victory A Scow Scantlings. The scantlings for the "NCASA Rule" A Scows will be under the jurisdiction of the NCASA.

6. The ILYA agrees to immediately seat a Fleet Committee and Fleet Representative elected by the "Box Rule" Class A owners that participated in its most recent Annual Championship. This representative would replace the current Class A representative.

7. For 2005 the ILYA agrees that the "NCASA Rule" A Scows at the NCASA National Championship will elect a Fleet Committee and Fleet Representative. The owners of "NCASA Rule" boats at the Annual Championship regatta will elect beginning at the 2006 Annual Championship, the "NCASA Rule" A scow Committee and Fleet Representative. 8. Beginning at the 2006 Annual Championship, owners are ONLY entitled to vote in the fleet meeting for the fleet in which they have most recently participated in the ILYA Annual Championship regatta.

9. The NCASA will agree to not run events overlapping the dates of the ILYA Championship or Invitational regattas for either fleet of Class A Scows.

10. The "old silver" will be awarded to the regatta and race winners of whichever fleet enters most boats (completing at least one race) in the Annual Invitational and Championship regattas. In the case of a tie, the fleet with the most boats in the previous year will race for the "old silver". In this way, both groups will have a strong incentive to build their fleets and increase attendance at ILYA events.

11. The NCASA and Bradley Robinson will each reimburse the ILYA for half of its legal fees incurred specifically in connection with the A Scow dispute.

12. All three parties will execute covenants not to pursue legal action against one another or pursue any other sanctions via a governmental entity, USSAILING, or ISAF.

Other Old Business was made moot by previous actions of the Board. Under New Business the discussion on the criteria by which the Board might add a new fleet to its regatta schedule was tabled to the Fall Meeting (C. Porter/Trester). The proposed language to discontinue a fleet from the regatta schedule was removed from discussion at the Fall Board meeting. A proposal for periodic review of builders was removed from consideration by consensus.

There being no further new business, Hodgson thanked all for their patience and hard work in working through the issues that were before the group, and the meeting was adjourned at 8:00 p.m. (Mann/Schmidt).

At the time of this writing, the ILYA Board of Directors has decided to discontinue racing in Class A indefinitely. If this decision is reversed for some reason and racing is once again scheduled, Class A will register and race in accordance with the same schedule as Classes C and M-16. entirely at their own risk. See RRS 4, Decision to Race. The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or

official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as а result of participation in this event. By participating in this event, each competitor, or in the case of minors, each competitor's parent or guardian, agrees to release the race organizers from any and all liability associated with such competitor's

participation in this event to the fullest extent permitted by law.

Rules

The regatta will be governed by *The Racing Rules of Sailing 2001-2004* and the prescriptions of the United States Sailing Association; the bylaws of the Inland Lake Yachting Association and its scantling rules for Classes C, I-20, and M-16; the scantling rules of the National Class E Scow Association and NCESA Bylaws Articles VI and VIII, parts 4, 5, and 7; Article IX and the Appendix of the bylaws of the International MC Class Scow Racing Association; except as any of these are altered by the Sailing Instructions, and by the Sailing Instructions.

Notification of OCS (on course side) starters and other communication in Class E will be done exclusively on VHF radio frequencies. Notification of OCS (on course side) starters and other communication in Classes C, MC, M-16, and I-20 will be done first by VHF radio and second by hailer.

In Class MC, electronic compasses and timing devices will be allowed.

Advertising

In accordance with ISAF Regulation 20, this regatta is classified as an "invitational" Category A event.

Registration, Weighing, Measuring, Launching, Mooring

Registration, weighing (as needed), measuring (as needed), and launching for all classes will take place at the Okoboji Yacht Club.

All boats and trailers entering West Okoboji Lake must be power-washed to prevent the spread of milfoil.

Bring your own mooring with 15 feet of line for a seaweed and silt bottom. Although dry sailing is allowed for all yachts at this regatta, no dry sailing will be permitted on the yacht club premises.

Classes C and M-16 will register, measure and weigh from 3:00 a.m. to 7:00 p.m. on Saturday, August 13. Classes E, MC

and I-20 will register, measure and weigh on Wednesday, August 17, from

3:00 p.m. until 7:00 p.m.

Registration is not officially complete until measurement and weight requirements have been checked, and sailing instructions have been received and signed for.

Please park in the designated areas and place your trailers in the designated areas to allow for appropriate traffic flow.



Warning: Classifieds Scam

You may have occasion to use the ILYA Scow Slants or the ILYA Web Site (<u>www.ilya.org</u>) to advertise a boat or related equipment. Evidently some scam artists have found the ILYA Web site and its classified ad page. One of our current advertisers told me he was contacted twice recently with the scam. I heard a similar story from two other ILYA members recently as well.

The scam works something like this (with possible variations): The interested person (scammer) supposedly has a friend or business acquaintance who owes him money. That money (more than you are asking for the boat) is sent to you in the form of a cashier's check (WHICH IS FAKE!). When you receive the cashier's check, you are supposed to deposit it and send a personal check for the overage amount to the scammer.

Here's how you get taken: The bank has no idea that the cashier's check is fake, so they accept it, and you send a good check to the scammer. After a few days, the bank finds out that the cashier's check was fake, and you are responsible for it. By then you are out your good check, and possibly the boat, if the scammer even bothered to come get it.

Skippers residing outside of the traditional Inland states of Wisconsin, Minnesota, Iowa, Illinois, Michigan, Indiana, and Missouri need not be members of ILYA member clubs in order to participate in ILYA sanctioned events.

Skippers residing within the Inland states listed above must be members of an ILYA member club, or must make special arrangements with the ILYA Executive Secretary prior to the first entry deadline.

Individual memberships in the ILYA are not required for persons serving as crew at Inland events. Persons who do register as crew members at ILYA sanctioned regattas will receive free subscriptions to SCOW SLANTS if crew addresses are supplied.

Random measuring of boats and sails is required at all championship events and at some invitational and regional events, but all measuring costs are included in the registration fee.

Sailors new to the ILYA can anticipate paying the entry fee and the skipper's regular membership in the ILYA. The only other registration and regatta costs should be for food and social activities.

TECH TALK - The New Foils Rule By Matt Wake, Sturgis Boat Works/Optimist USA

Here's the Deal: The International Optimist Dinghy Association (IODA) has ruled that Optimist foils (rudder and daggerboard) should be more "one design" and "less expensive". Pretty good idea. However, they have accomplished this by writing rules that have produced foils that are both different from all existing foils and more expensive to build. Does that make sense? Well, let me explain. Let's start by answering a few questions.

Are My Blades Still Legal?

Yes and no. If your blades have been measured, or you get them measured and certified by March 1, 2005, your blades will be "grandfathered" for use at regional and national regattas within the U.S. If not, IODA considers your blades illegal. However, at the last meeting of the USODA Board of Directors, they made a ruling that will buy their members time in complying with IODA's measuring requirements.

My advice to Optimist sailors is two-fold. First, don't panic! USODA has extended measurement deadlines and is providing more and easier paths to certified measurement. Second, make an effort get your blades measured. Measurement will be available, even for non-competitors, at every major USODA event. Don't put off measurement if you don't have to.

Although "old style" blades that have been measured and certified will be grandfathered for legal use, there are some exceptions. In 2005, all competitors at the World Championship will be required to use the new rule blades; by 2006 all competitors at all continental championships will be required to use new rule blades. While USODA has come up with a stopgap maneuver, that does not change your responsibility to get your blades measured.

What's the Difference?

The "New Rule Blades", "'05 Foils" or whatever you'd like to call them, are different from the old foils in several ways:

1) they must be made of glass, foam and clear epoxy;

2) they are slightly (2mm) thicker in both the rudder and daggerboard;

3) they don't have carbon tillers, they've been ruled out; and

4) the rudder profile, for the first time, is very tightly controlled.

What's the Same?

The profile of the daggerboard is unchanged. It's just a little thicker. The underwater profile of the rudder is very similar to the old style N1 or E&V rudder; it is a very "middle of the road" shape in terms of its angle of attack.

What's It All Mean to Me?

The cost of producing new tooling for these foils, the expense of the materials and the difficulty of building attractive foils from clear epoxy will combine to make the new foils at least as expensive as top of the line wood/ epoxy (Teb, E&V, N1). Ultimately, the price will drop as production and competition grow but in the short term don't expect less expensive blades. On the plus side, blades will be more similar and eventually prices should fall.

Are the New Foils Better, Faster?

This is another "yes and no". For most sailors, the new rule blades will be both faster and better. Faster because they are thicker and stiffer, better because they seem genuinely tougher and lower maintenance. Certainly they will be far less likely to warp than wood/epoxy blades. My guess is that the exception to the "faster" rule will be very light sailors, who don't need the extra stiffness and would be better off with the more swept back designs of the old style Teb and Winner blades. The swept back rudders moved the center of resistance further aft, which better balanced boats with the 108-111 rake measurements common for lighter sailors. Very heavy sailors (113.5-115 rake), and very good helmsmen might be better off with the high aspect rudders, like the Teb Elliptical but, I think this will be outweighed by the greater stiffness of the new rule blades. Furthermore, the foam epoxy construction should give sailors a remarkable strong and chip resistant blade.

Sail fast, and see you at the next regatta! Matt Wake

182 boats came to this years Team Trials. 14 of those were ILYA kids and 13 of those sailed under the MOST banner. Coaches were Soeren Laugesen and Steph Roble.

Measurement hassles were greatly minimized this year and kudos to USODA for that. Pre-regatta preparation began the weekend before the event as most of the kids came to Annapolis for a two day practice and about half of them stayed for the week. This would be a venue where we could expect big wind shifts, especially with any westerly component to the wind. In addition, the famous currents would come into play and the kids had to be aware of those.

The fleet was split into four color groups that would sail a round robin. The red fleet was stacked, especially if it was going to be breeze on. Breeze off would have meant the Green Fleet would have been especially strong. Joe, Anne, Colin and Brendan were in the Red with a couple of other strong sailors. Red took 5 of the 11 top spots at the regatta (arguing, I think, for seeding).

The first race got off in a light

breeze that remained remarkably steady, but continued to drop as the race went on. Finally, they just pulled the plug on the race and sent them home after day one with nothing on the board.

Luckily for the event, there was a late season nor'easter that came and just skimmed us. So there wasn't a ton of rain, but there was breeze. Day two featured breeze from 12 to 20 and the regatta was on. There was some lump in the AM as the breeze was with the current and in the afternoon the lump really came on. Some of the less experienced kids were really struggling, particularly in the afternoon. In the meantime, both Haegers and Smith put races in the top 6 and Joe did his usual get the throwout out of the way early thing with a still not bad 21. Brendan started ok with a 22.

Race 2 saw Will make a late charge for a bullet and Joe, Anne and Colin safely in there with top 7's. Steph Hudson had her best race of the event with a 19. The starts were very difficult in the afternoon as the current switched and the kids were being pushed over the line.

Anne got nailed with an OCS, ending the day with not a lot of room to maneuver. Will, Joe and Colin stayed in the top 7 to stay right up there

and Brendan stuck a 13 to hang close. The breeze sort of pooped and came from all over the place. In they went after only 3 races.

PRO threatened the kids with up to 6 races on day 3 and the wind was down from day two, but again looked to cooperate. Anne came back hard on the last trip up in about 12 knots to take a bullet and Colin continued to be very strong with a 5. Will lost a 4 to a ZFP

Race 5 saw the wind remain in the 10-15 range and Anne and Will stayed tough with a 3 and a 5 respectively. Colin and Joe were just a little back with a 12 and a 13 and Brendan got it going again with a 9. For race 6, the breeze was down and shifty and this would be a very rough race for some of the leaders, including Colin who went the wrong way uphill and rounded about 40. There was some confusion in the transmissions from the race committee about Will and whether or not he got a Z flag penalty or not. But, he took a 4 and so did Joe to stay strong. Brendan kept it going with a 5 as he learned that coming in from the left into the finish was the way to go. Robbie Johnson finally got it going a little for a 17 which would be his best race of the event. Nick Clemence and Spencer Jones also had great races with a 21 and 23 respectively.

Race nine saw Will Haeger swamped the first trip up and barely made it around the course for a 40 and his throwout. Anne worked her way through the fleet and ended up with a 4. She was clearly the fastest boat out there uphill, just working hard and flying. Colin and Joe each put in top tens to be right there for the Worlds. Going into race 10, we knew that Colin and Joe were

> right there and we knew that Will had blown his big lead.

He was either going to get it together right then or not go to the Worlds. It was also clear, that as quick as Anne was going that the only thing that was going to stop her was if they didn't get in that 11th race. In race 10, Anne and Colin both got off to poor starts, but got around about 10, in a pack that included Brendan, just behind the leaders who included Joe.

Going into the last day, Will was 1 point out of the lead and the three leaders were well clear of the pack. There was a real dogfight from Colin in 5th through 10 (Joe in 8th) were 5 points separated. To further complicate matters, if they were able to get another throwout in Anne was standing very strong for the event. Her biggest issue was that they did not change the starting time for the next day and they could not start a race after 2PM. Four races would be needed for throwout.

The last day the breeze was consistently 20-30 and there was much to play for. Anne and Colin powered through the fleet for a 1,2 and Joe was right there with a 7. Will struggled and struggled but finally finished with a 24 which brought him right back to the pack. In the meantime, Will Howard was digging the breeze and put together a

Colin did not have a very good run and then compounded it by going right the last trip up and limping in with a 32. Joe hung in there tough with a 4 and Anne did her usual drive through the fleet to lead right until the end when a big lefty put her back to 2nd. Another big beneficiary of the lefty was Brendan who put another 5 on the board.

In the other race, which I could not watch, Will took off from the boat end (first time all event) and headed way left (every time all event) to round just in the top ten. He was finally playing his sheet a little and keeping the boat flat. He had his usual strong reach (if there is one thing that separates him it is the reaches) to round 3rd. Downhill the leaders got hit with a huge shot that caused two of them to roundup and Will rounded first at the bottom pin. For some



On a windy day, especially as you fight your way off the starting line in close quarters, you can hear the calls from the talking heads of your nearest competitors: "Puff in $3 \dots 2 \dots 1 \dots$ followed by a lull and two steep waves." Getting this kind of input back to the helmsman is critical, not just at the start, but all around the racecourse, because as you know, huge gains can be made by taking advantage of puffs and lulls, both large and small.

It's important as a crew to communicate what's happening with the wind, and do so with confidence. To call a puff effectively, you need to recognize one, determine its size, estimate how strong it is, and figure out what direction it's moving. But before I go any further, let me stress that it's just as important to call the lulls preceding or following a puff.

Remember, a puff is simply an increase in breeze big or small. When I'm calling puffs to the helmsman, I refer to them as fan puffs or directional puffs. A fan puff is the leading edge of a gust, a mass of air dropping from aloft and fanning out from its center of impact as more air piles on top of it. A directional puff is essentially the remnants of the fan puff, overcoming the initial surface contact and moving in the direction of the upper air mass from which it came.

The initial puff is always a fan puff. Its appearance is generally darker and more solid than a directional puff, and it will appear on the water as an expanding oval. After a short period, the puff stops spreading as the air overcomes the initial surface resistance and moves in the same general direction—now it's a directional puff. Puffs will come from the prevailing wind direction, so figuring out where they're coming from is a matter of scanning the area to weather to see where they originate. Watch to see if a puff is expanding to the sides: if it's still expanding, it's still fanning. If it's just moving straight, it's a directional.

You'll commonly hear people refer to "lifting puffs" and "heading puffs," which is simply a matter of which side of the puff you're engaging. You can determine this by the direction from which the puff approaches. If it's coming from aft of about 60 degrees to your course it's a lift, forward of that to 45 degrees it's the median, and forward of 45 degrees it's a header.

Determining how soon it will hit, and thus the countdown, is a matter of figuring out how fast it's moving over the water. You can count down aloud by how fast you see it coming. If you start counting faster, the helmsman knows it's coming faster with more pressure; if you slow your count it's coming slower with less pressure.

What about the lulls? The lulls will appear ahead of and behind the puffs, and it's important to let the driver know whether a lull is less or more than the pre-puff velocity. Their shapes and lengths are difficult to determine, so I don't really try. I look for the next change on the water and try to guess how long it will take to get to it. Simply calling out the lull gives the helm and trimmers the opportunity to change gears. The lulls are going to last until the next puff hits, so the best thing to do is start looking for the next puff.

Upwind, keep calling 'em

With this background, it's time to learn how to relay the information to the helmsman. Picture the following situation, sailing upwind: What I might see and tell myself is, "A large area of breeze is coming from directly abeam, but not very quickly." What I should tell the helm is, "Small lifting puff, lasting 20 seconds, hitting in 3 . . . 2 . . . 1, breeze on." Note that even though the puff is big, its slow movement indicates there isn't necessarily a lot of breeze in it. Armed with this information, the helm can make changes in sheet tension and adjust the backstay for what he knows will be a long period. Knowing that it's a lifting puff allows him to ease as the puff hits in order to let the boat accelerate. He then turns up as he re-trims the sheet.

I occasionally give the helmsman extra information if I think he can deal with it and break it down fast continued on page 54

enough. For example, what I might see and say to myself is, "Lots of breeze (really dark water), in a very small patch, same direction as current breeze, coming fast." What I tell the helmsman is, "5 knots more breeze, this direction, lasting 7 to 10 seconds, followed by a lull, and then the same breeze we've had, in $3 \dots 2 \dots 1$." This allows the helmsman to make a drastic adjustment for the puff, knowing how long he has to stay depowered, when he can start to power up again, and to what degree.

The other important ingredient in the above example is information about the lull. Doing this allows the boat to be properly powered up when it needs to be. As the wind fills after the lull, the call will be much the same as calling a puff. What I say to myself is, "Flat water, no ripples for a while, darker line about 200 yards away, coming slowly, with about the same pressure we had before, same direction as before." What I tell the helm is, "Lull for 15, slowly building breeze for 20, back to what we had, initial velocity lift, steadying out to the median. Small increase in 5 . ..4...3...2...1."

The helm knows he has to live with this breeze for a short time and trim for it. He knows how he was set up before the lull and when to return to the pre-lull trim settings. He also knows the boat's heading so he can let the boat climb to its previous heading as the puff hits. Giving an accurate countdown with a gap gives the helm time to consider when to start making fine-tune adjustments.

Downwind: Look behind

The best part of calling puffs downwind, especially on a keelboat, is that it's usually possible to stand and see them from a higher vantage point, which allows you to track the direction of the puff more accurately and gives you a better idea how much wind there is in the puff.

When calling puffs, scan everywhere behind and determine whether a dark patch is easy to get to. If you can, you generally want to head for a nearby puff or to at least place yourself in front of it. As you reach a puff, you'll usually get an initial header. As the puff begins to fade, and you enter its center, you'll slowly be lifted. If there's still pressure in the puff, you can jibe onto the headed tack and stay with it until the breeze returns to the median pressure. Then start looking for another puff.

Puffs that are abeam will probably be gone before you can reach up to get there so don't bother. It's better to look directly up the course to watch for puff development. If a puff isn't really catching up, then it's important not to chase it around trying to get in front of it, often it's better to sail less distance and let a puff go by.

A few more things to remember downwind: If the puff approaches from the left (looking upwind), it's a "lefty," from the right it's a "righty." If it's filling from astern, track its direction and figure where you are in relation to its inside edge—that's where you want to place yourself. Boats behind are perfect clues as to what the puffs are doing. Generally, the boats toward the edges will jibe toward the middle of the puff so they sail the headed tack, or they will try to sail low toward the center in more pressure.

The most important part of calling puffs downwind is to make sure you maximize the time you're in the increased breeze. With this in mind, I'll often tell the helm to steer low because the breeze is going from windward to leeward. My advice to the helm as I do this is to "maintain pressure, stay low until the chute starts to de-pressure, then slowly head up for speed build." This allows maximum leeward separation from weather boats or allows you to get down into a different lane for tactical or clear-air considerations. Staying artificially low will also allow you to re-align for the next puff without having to jibe for it.

There's generally less talk about the characteristics of the puffs downwind since they come to you slower and you stay in them longer. As a tactician, you tell the helm whether to sail a VMG course or a course

that will keep them in the puff the longest—there isn't much more you can say. A typical conversation when seeing a puff coming from astern is "building breeze going right to left, build speed and take it down when you're at max pressure." The important conversation deals with telling the driver when to shift gears from sailing in the current puff and setting himself up for the next one. The biggest mistake people make is not recognizing when they're in a dying directional puff; you'll have to step up to the next puff because the directional puff won't fan to you. Don't be afraid to make a quick but drastic course change to get to a lot more breeze, the pressure will allow you to extend and roll down later.

The hardest part of talking to the helm downwind is trying to figure how long the puff will last. Upwind you're sailing toward the puff so you'll usually see some increase, even if the puff is dying, and it will increase as you get toward the middle. Downwind it's possible to outrun the puff and it's very important to let the driver know that the breeze is dissipating. I'll often see a puff with a small increase and relay that, but in these situations, it's critical for the spinnaker trimmer to let the driver know when they feel the breeze in the chute—you can't turn down until the chute is loaded. When you have the pressure, you have to recognize where in the puff you want to be. The air inside a puff is semi-turbulent and may be a little unstable, on the edges it tends to be more defined and solid. However, the breeze on the edges is usually less so pick your poison.

reason, he sailed the right side the last trip up to drop a few, but still put a 4 on the board. His World dreams would depend on how bad race 8 was and we had no idea except that we thought maybe 30. Now Anne had to wait to see if they would try another one. Time was tight as we waited for the 20 minute deadline for the stragglers to come. Just before 2PM, the PRO pulled up the anchors and sent them in. In all that breeze while a lot of the less experienced kids didn't finish, Spencer Jones not only finished every race, but refused a tow in. Pretty cool for him.

Anne and Colin knew they were done but Joe and Will knew they had hope. As we took the boats apart, no one knew if they had made it. Finally a phone call from the internet with news that Will had a 24 in the first race made it pretty clear that he was in. Next the rest of the scores were posted and the sad news that Joe had missed his second trip to the Worlds by only 4 points.

All the ILYA sailors that went out to the Trials learned a lot and improved their skills by leaps and bounds.
