events like match racing, we don't have referees or umpires. The racing rules are enforced by the competitors themselves, and breaking a rule is a big deal even if no one else sees it.

A set of sportsmanship guidelines:

- Apply the golden rule: Do unto others as you would have them do unto you.
- Understand and appreciate the rules.
- Enjoy yourself and encourage enjoyment of others.
- Take responsibility for your actions.
- Exhibit respect for the officials.
- Do not tolerate bad behavior from your teammates.
- Cheer in a positive manner.
- Accept all decisions by officials without question.
- Applaud good plays by teammates and competitors.
- Applaud at the end of the contest for the performance of all participants.
- Encourage all surrounding people (fans included) to display sportsmanlike behavior.
