## Resources Statement

Any employee or sailor that participates in summer programming will have the responsibility to decide if they are willing to take that risk.

The author of this document is the HIYC Summer Sailing Director, reviewed by the NSF Board of Directors. The document will be updated as needed with revision dates noted. The medical administrative point person for all COVID related issues will be the Summer Sailing Director or, on the Director's absence, the Assistant Director.

## Employee Safety

All employees and volunteers of HIYC Sailing Camp will first need to sign a medical release waiver (see in the Waivers section).

The following preventative actions will be in place to keep employees safe:

- Employees will be told that they should not come to work if they feel sick or if anyone in their household has tested positive for COVID19 (this will also be stated in their signed waiver).
- If an employee has a fever of 100.4F or greater, they will be isolated and sent home. An incident report will be filled out. Any surfaces they may have touched will be disinfected.
- If an employee begins to feel sick while at work they will immediately tell the Director and isolate themselves until they can leave the facility.
- No medical records will be kept for normal temperature readings, only for fever readings. All fever incident reports fall under HIPPA laws and will not be disclosed except to the employee or guardian.
- An employee can return to work 10 days after the onset of symptoms or with a negative COVID rapid test after day 6 of exposure and no symptoms.
- If an employee has direct contact with a person (less than 6 ft for more than 15 min or live in the household with them) that tests positive for COVID the following applies:
  - The employee must isolate for 10 days after the contact with the infected person and may return after 10 days if there are no symptoms or;
  - The employee may take a PCR test and present a negative result
  - The employee may take a rapid test on day 6 after the initial contact with the positive person and present a negative result
  - If the employee begins to exhibit symptoms, then the employee will be able to return to work 10 days after symptom onset if no symptoms are present

#### Rescue

According to recommendations by the Red Cross, if CPR is needed, **Instructors will NOT perform any mouth to mouth procedures, but can perform hands only compressions until professionals arrive**. For any minor medical issues such as scrapes, splinters, etc, Instructors will wear face covering and gloves and will provide first aid provisions to the sailor for them to treat themselves if possible. If assistance is needed, gloves and face covering will be worn by instructor and sailor while treating the issue.

### **Cleaning and Disinfecting**

At the end of each session, all high touch points will be cleaned with an environmentally safe soap and water viralcide. These areas include but are not limited to:

- Coach boat driving mechanisms
- o Radios
- o Tillers
- Main Sheet / Jib Sheet and other controls
- Sails and sailbags
- Sprit poles
- Hoses and sprayers
- o Tools
- o Classroom chairs
- o Tables and counters
- Employees will use the Yacht Club restrooms and will wash their hands before sessions begin and have time to wash hands throughout the day.
- Hand sanitizer will be provided for employees and sailors' use.

#### PPE

- Employees should provide their own face coverings. Buffs will be acceptable. All face covering should be washed each evening. If employees do not have face coverings, HIYC will provide disposable masks.
- Medical gloves will be provided in the first aid kits.

#### Food / Water

- Employees will be required to bring their own lunch and should not share food.

## Sailor Safety and Protocol

The following minimum preventative measures will be taken to provide a safe environment for sailors. Instructors along with the Summer Director will be responsible for enforcing these measures.

#### Registration

- During registration, parents are asked for any health issues of the sailor. HIYC/NSF reserves the right to refuse a sailor if they have autoimmune disease or any issues that would not allow them to social distance.

#### Sign-in and Social Distance in the Facility

- Parents and guardians will receive all pre-session information including this policy one week before their session begins.
- Parents will be asked to stay in their car during drop off and pick. Instructors will meet the sailors in a car drop off line where sailors will be checked in. Pick up will be done in a similar car line fashion.
- Social Distancing and reminders about PPE will be in place on posters around the facility
- Most all activities will take place outside and social distancing will be encouraged.

#### Personal Belongings

- All personal belongings MUST be taken home after each session. There will be no locker or cubby storage available after sessions
- All sailors must have their own personal life jacket (PFD) and must take it home with them after every session.

#### Bathrooms/Water/Food

- All arriving sailors will be taken to the restroom at the beginning of each session to wash hands or use the bathroom as needed. Additional restroom breaks will be provided at for hand washing and restroom use as needed. Restrooms are part of the Harbor Island Yacht Club Marina and will be cleaned each day.
- No showers will be available for use
- WATER JUGS will be provided to refill water bottles. If you do not want your child to use the HIYC water jugs, please provide enough water for the full day
- Food cannot be shared and no snacks or food will be provided by HIYC (except on Friday Pizza Lunch awards day)
- All snacks and lunches will be eaten outside with social distancing.

#### **Equipment Rigging**

Sailing typically involves group effort to rig and launch boats. HIYC will take extra precautions to make sure that social distancing takes place during rigging.

#### **Boat Occupancy**

Sailors are typically paired with at least one other student during camp for sailing. Each sailor guardian will be given a waiver asking 1) can your sailor be in the boat with others? 2) Does your sailor need to sail alone 3) is there a preferred partner that your sailor must sail with?

#### **PPE requirements**

- All sailors will be required to wear a buff or cloth face covering when inside the HIYC clubhouse / classroom with a large group (such as during storm events) ONLY. Face coverings are optional all other times.
- Sailors are not required to wear face coverings when on the water
- Sailors will not be required to wear face coverings when outside
- All sailors will be required to have a buff or face covering to enter their session, but paper disposable masks will be available if needed.
- Full exemption of masks can be provided by doctor's note or proof of vaccine
- Medical gloves will be provided by HIYC when needed for first aid or when using high touch equipment


#### Sick Child Protocol and Reporting

If a child begins to feel sick with any COVID symptoms as described by the CDC, the child will immediately be isolated in an outside space with instructor observation.

- A temperature reading will be taken.
- Guardians will be called immediately to pick up the child.
- The sailor will remain in isolation until picked up.
- An incident report will be filed and subject to HIPPA laws will only be shared with the guardian.
- All employees and sailor families will be informed that there was a sick child at the session.
- If a sailor or anyone in the household of the sailor tests positive for COVID, all employees and participants will be informed of the positive but not the identity of the sailor.

#### Return to Camp

Wilson County School protocol will be followed for return to camp. If days are missed, HIYC Director will work with families to reschedule those days if needed.



## Weather Provisions

Weather will be monitored 24 hrs in advance for possible situations that would keep sailors from being outside and in a more crowded space

- Rainy day activities can safely be conducted on clubhouse porches to wait out short rainstorms or light or too heavy wind.
- The Director may cancel daily sessions if the weather is predicted to be severe or if the chance of rain is 80% or higher for the entirety of the daily session, the session can be canceled by 7pm the night before to avoid a large group of sailors being stuck in indoor classrooms for extended periods. No refunds will be given for severe weather days except as noted in the refund policy.

## Media Response

All media and interview requests will be directed ONLY to the Summer Sailing Director or the Chair of the Board for Nashville Sailing Foundation

## **Refund Policy**

- If the session has already started, no refund will be issued for illness or any other reason per the HIYC Refund policy
- If a weekly session has 3 or more days of cancellations due to weather, refunds may be issued on a daily prorate for those days missed.
- If a session is canceled because of government health orders, a full refund will be issued.

#### HIYC Sailing Camp – Nashville Sailing Foundation Employee COVID Waiver

(Hereinafter referred to as "HIYC/NSF")

I, \_\_\_\_\_\_\_, do hereby affirm, that I am the legal employee or volunteer of HIYC/NSF and by my signature hereto, I do expressly consent, authorize and agree to the following participation in HIYC Sailing Camp.

#### PARTICIPATION CONSENT - WAIVER OF LIABILITY - ASSUMPTION OF RISK FOR ILLNESS AND DISEASE:

I have received training on the HIYC/NSF COVID Prevention Policy and understand my responsibilities to carry out the safety policies. I do hereby further consent, authorize and agree as set forth below concerning the COVID pandemic:

- A. **CONSENT:** I understand and consent to having my temperature scanned and that I will need to adhere to policy for personal protective equipment (PPE)
- B. **HEALTH:** I am in good health, and not exhibiting any symptoms as described by the CDC, of the COVID19 virus at this time. I also attest that my household does not have any positive cases of COVID19 at the time of the session.
- C. **ASSUMPTION OF RISK:** I am aware that the activities of camp are group activities. While HIYC/NSF follows a COVID19 prevention policy developed with resources from US Sailing, the CDC and local and state government, no social distancing, PPE and disinfecting regimes are 100% effective in preventing transmission. With the knowledge of the risks involved, I continue as an employee or volunteer.
- D. WAIVER OF LIABILITY: I waive and release my rights that I, my heirs, distributees, guardians, legal representatives, and/or assigns may have or acquire to make a claim against, sue, attach the property of or prosecute the HIYC/NSF or any of their members, directors, officers, agents, employees and affiliated organizations (herein referred to as "the releases") for monetary damages due to illness or disease.

I ACCEPT ANY AND ALL RISKS TO DUE TO ILLNESS OR DISEASE AT THE HARBOR ISLAND YACHT CLUB AND THE NASHVILLE SAILING FOUNDATION, WHETHER OR NOT CAUSED BY NEGLIGENCE OR OTHER ACTION.

This consent and authorization shall remain in effect until the Employee or Volunteer, granting this consent/authorization, notifies HIYC/NSF in writing, that said consent/authorization is revoked.
