#### SPECIAL RULES AND REGULATIONS:

1. You are reminded that your organization is responsible for safety in the regatta area and that this permit does not relieve you of such responsibility. Participants shall be adequately briefed and their boats equipped as required by law. In the event of any change in the information furnished in your

application you shall notify this office.

- 2. Permitee subject to any special rules and regulations as specified by the NYS Department of Transportation, the pertinent County Sheriff's Dept. or any other navigation law enforcement officer having jurisdiction on the waterway. There must be no obstruction to commercial river, canal or lake traffic and the permittee must provide for an effective means of communication between all responsible parties to insure uninterrupted passage to all commercial traffic.
- 3. Exclusive use of the waters referred to in this permit is not granted to the permittee. Special Navigation linspectors must provide for safe passage for other vessels through the race course heats or at other specified intervals. The channel proper must be avoided at all times possible, and always when commercial traffic is present
- 4. "Rules and Regulations Pertaining to the Conduct of Regattas" (9NYCRR 447) is attached and shall be considered an integral part of the permit. Special markers constructed of light self-buoyant materials may be placed in the indicated waters but must be removed at the conclusion of each day's event.
- 5. This permit in no way allows encroachment upon private or state park lands.
- 6. After the event the permitee shall be responsible for the cleanup of regatta debris.

Pursuant to provisions of Section 34 of	the New York State Navigation Law, permission is hereby granted to the sponsoring organization and the person in
